Hourly Rates

Hourly rate starts upon arrival at origin and end when the last delivery is completed. Minimum requirement is 4 hours; additional hours billed in 1/4 hour increments.

Regular Hours are 7:00 AM to 5:00 PM Overtime rate applies after 5:00 PM

All cartons packed will be done at a per container rate, this includes all materials and labor. All cartons unpacked will be done at our normal hourly rate stated above in section 1. Hourly Rates.

Hold Over Charges

Cost of holding a straight truck (24ft or 26ft) or trailer (53ft) is \$400 per night. Please note that carrier may be unable to hold straight trucks for an extended period of time and may have to offload straight trucks into a storage trailer after one night at full expense of the shipper/Client.

Fuel Surcharge

Fuel Surcharge shall be calculated based upon one-way mileage Round trip would double rate.

50 miles +	(\$150)+\$5 each additional 10 miles

Travel Time

An additional charge to the actual hours shall be assessed for each vehicle, driver, and helper(s) to cover their Travel Time. Such charge shall not be applied more than once during any one day to the same shipper for the same vehicle and driver, helpers or supervisors. Travel Time Charges shall be calculated based upon one-way mileage.

Mileage	Charge
1-15 miles	½ Hour travel time
16-30 miles	1 Hour travel time
31-40 miles	1 ½ Hour travel time
41-50 miles	2 Hour travel time
50 miles +	2 Hour travel time + 1/2 hour for each additional 20 miles
