## INSTRUCTIONS FOR ACCESSING BUAR's HYBRID PUBLIC MEETING

This BUAR public meeting is being held in a "hybrid" format (i.e., in-person in Conference Room 9102 of the 9th floor of the "Saltonstall Building" at 100 Cambridge Street in Boston, MA, and via remote-access technology). This meeting format conforms with the Commonwealth's temporary provisions (effective through March 31, 2025) pertaining to the Open Meeting Law, signed into law by Governor Healey on March 29, 2023, allowing public bodies to continue holding their meetings remotely without a quorum of the public body physically present at a meeting location, and to provide "adequate, alternative" access to remote meetings. Instructions for accessing the meeting remotely and in-person are provided below. Any questions regarding access to the meeting should be directed to David S. Remote participants are encouraged to log-in 5 minutes before the scheduled start of the meeting. Upon log-in, participants will be placed in a waiting room prior to being admitted into the meeting by the host. To prevent inappropriate online intrusions into Board business, all remote-access public participants with and without business before the Board on the meeting's agenda will have their audio function muted and their chat and video functions disabled. Remote-access public participants with business before the Board on the agenda will be unmuted when the Board takes up their business.

### In-Person Access

Upon entering the "Saltonstall Building" at 100 Cambridge Street, Boston, MA, proceed to the building's security check-in area, tell them you are there to attend the BUAR's public meeting, and show a photo-ID to receive a guest name tag. To facilitate the check-in process with security, a list of the names of Board members and public participants with business before the Board has been provided to security staff. Upon clearing security, proceed to the elevators and go to the 9th floor. Upon arrival on the 9th floor, proceed through the glass door into EOE's office reception area. The Board's Director will be waiting there to greet you and guide you to Conference Room 9102 where the meeting will be held.

*(Special note: Parking is available in local parking lots [see below]. These lots are very expensive and we recommend taking public transportation. See MBTA Directions).*

### **Driving from the North via Route 1:**

- Take Route 1 South.
- Cross the Tobin Bridge (through toll plaza) and take first exit toward Somerville/Charlestown (stay in the right lane).
- At light, turn right and merge onto MA Rt. 99 South toward Boston.

- Cross bridge and at light turn right onto Causeway Street.
- Get into left lane and follow Causeway Street until it becomes Staniford Street.
- At light, turn left onto Cambridge Street.
- Saltonstall Building is at the next intersection on the right.

**Driving from the North via Route 93:**

- Take Route 93 South.
- Take Route 28 N/Route 3 N, Exit 26 toward Storrow Drive/North Station.
- At fork, bear right towards North Station.
- At lights, turn slight right onto Nashua Street.
- Turn left onto Lomasney Way.
- Turn right onto Staniford Street.
- At light, turn left onto Cambridge Street.
- Saltonstall Building is at the next intersection on the right.

**Driving from the South:**

- Take the I- 93 South to Boston.
- Take Exit 23 to Government Center
- Turn left.
- Turn slight right onto North Street.
- Turn right onto Congress Street, which becomes Merrimac Street.
- Turn a slight left onto New Chardon Street.
- Turn left onto Cambridge Street.
- Saltonstall Building is on the right.

**Driving from the West:**

- Take the I- 90 East (toll road)
- Take Exit 22 toward Copley Square
- Turn slight right onto Stuart Street/MA 9-E
- Turn left onto Charles Street S/MA-28N
- Turn right onto Beacon Street
- Turn left onto Bowdoin Street
- At lights, turn right onto Cambridge Street.

**MBTA Directions:**

- Green Line: Take the Green Line to Government Center. When you exit the station walk to the left. You will see a curved building. (This is Center Plaza). Cross Cambridge Street, and take a right. Follow Center Plaza to the end of the block, the Saltonstall Building will come up on the left-hand side.
- Orange Line: Take the Orange Line to Haymarket Station. When you exit the station, cross Congress Street and proceed onto New Sudbury Street. At the top of the hill, New Sudbury Street intersects Cambridge Street. The Saltonstall Building will be across the street to the right.
- Blue Line: Take Blue Line to Bowdoin station. Exit station and cross Cambridge Street, the Saltonstall Building will be in front of you.
- Red Line: Get off at Park Street Station. Transfer to the Green Line. Take the Green Line to Government Center station. Follow the Green Line directions above.
- Silver Line: Get off at Downtown Crossing. Transfer to the Red Line. Take the Red Line to Park Street station and transfer to the Green Line. Take the Green Line to Government Center and follow Green Line directions above.
- Commuter Rail (from South): Transfer to the Red Line inside of South Station and follow Red Line Directions above.
- Commuter Rail (from North): Once outside the station, take a right onto Causeway Street, which will become Staniford Street. Follow Staniford Street until the end. Take a left onto Cambridge Street. The Saltonstall Building will be one block up on the right.
