**Massachusetts-Ireland Trade Commission 2025 Annual Report**

Section 42 of Chapter 140 of the Acts of 2024 (“Authorizing Statute”) established the Massachusetts-Ireland Trade Commission (“Commission”) within the Massachusetts Office of International Trade and Investment (“MOITI”).

Pursuant to Section 13V of Chapter 23A of the General Laws, as inserted by the Authorizing Statute, the Commission’s mission is to "evaluate the economic interests of, and review ways to strengthen the relationship between, the commonwealth and the Republic of Ireland. The Commission shall study, research, analyze and make recommendations related to: (i) bilateral trade and investments between the commonwealth and the Republic of Ireland; (ii) policy issues of interest to the commonwealth; (iii) business and academic exchanges between the commonwealth and the Republic of Ireland; (iv) mutual economic support; (v) investments in the infrastructure of the commonwealth and Republic of Ireland; (vi) the creation of economic and educational opportunities for aid to communities in the commonwealth and the Republic of Ireland; and (vii) other related issues as the commission deems necessary.” *See Appendix A.1 for full authorizing language.*

The Commission is required by the Authorizing Statute to annually submit a report that describes its findings, together with recommendations for any legislation, to the Governor, the Clerks of the House of Representatives and the Senate and the Chairs of the Joint Committee on Economic Development and Emerging Technologies.

The Commission consists of 15 members including legislators, gubernatorial appointees, and representation from the Executive Office of Economic Development. *See Appendix A.2 for full Commission membership.*

## **Activities Taken to Support the Massachusetts-Ireland Trade Commission:**

### Research:

- MOITI conducted research and discovered that Ireland was Massachusetts' 6<sup>th</sup> largest trading partner with over \$3.3 billion worth of goods exchanged in 2024.
  - In 2024, top export products from Massachusetts to Ireland included: (i) pharmaceutical products; (ii) medical/surgical equipment; and (iii) industrial machinery – totaling over \$889 million.
  - In 2024, top import products from Ireland to Massachusetts included: (i) medical/surgical equipment; (ii) industrial machinery; and (iii) special classification provisions – totaling over \$2.4 billion.

### Inaugural Meeting of the Massachusetts-Ireland Trade Commission:



- June 2025 -- MOITI Executive Director Jeevan Ramapriya chaired the Inaugural Meeting of the Massachusetts-Ireland Trade Commission. After introductory remarks by Commission Members, invited dignitaries, including Consul General of Ireland to New England Síghle Fitzgerald, The Honorable Neale Richmond, Minister of State at the Department of Foreign Affairs and Trade, and former U.S Ambassador to Ireland Claire

Cronin shared their perspectives on the deep cultural, diplomatic, and commercial ties between Massachusetts and Ireland.

- Representative John Lawn highlighted the growth of the Massachusetts Irish Legislative Caucus and its international collaborations, while UMass President Marty Meehan underscored academic partnerships with Irish universities and workforce development initiatives, particularly in MEDtech.
- Irish Minister Neale Richmond and former U.S. Ambassador Claire Cronin, reaffirmed the importance of fair trade, Ireland's economic evolution, and the strength of Ireland-Massachusetts ties, noting that Ireland is Massachusetts' sixth-largest trading partner.
- Key takeaways centered on expanding trade in pharmaceuticals and technology, strengthening cultural exchanges, and advancing education and workforce development initiatives.

### Diplomatic Engagement:

- March 2025 -- Governor Healey, former Undersecretary Sarah Stanton, and MOITI Executive Director Ramapriya met with the Minister of Enterprise and Trade, The Hon. Peter Burke, and Irish Consul General to New England Sighle FitzGerald, to discuss historic ties between the Commonwealth and the Republic of Ireland, both cultural and economic. Also discussed were upcoming events such as the Massachusetts Irish-Trade Commission Inaugural meeting in June alongside the 250<sup>th</sup> Celebration of the American Revolution.





### International Business Development:

- February 2025 --- MOITI met with [Protex.AI](#), a Dublin-based artificial intelligence company specializing in leveraging AI for workplace security. Protex.AI established their US Headquarters in Boston, MA.
- June 2025 --- MOITI met with [EclimAI](#), an Irish AI-driven energy efficiency company focused primarily on applications in cleantech. Their systems are designed to reduce waste and support global sustainability.
- July 2025 --- MOITI Executive Director Ramapriya meet with Professor William Scanlon, CEO of the Cork-based Tyndall National Institute at a luncheon hosted by UMass Lowell's Chancellor Julie Chen and the Senior Executive Director of the Rist Institute for Sustainability and Energy and a Commissioner of the Massachusetts-Ireland Trade Commission, Ruairi O'Mahony.

#### Appendix 1:

### **ENABLING STATUTE OF THE MASSACHUSETTS-IRELAND TRADE COMMISSION**

#### **Ch. 140, Section 42 of the Acts of 2024**

#### Section 42 Massachusetts Ireland Trade Commission

Chapter 23A of the General Laws is hereby amended by inserting after section 13U the following section:-

Section 13V. (a) There shall be a commission, within the international trade office, on Massachusetts-Ireland trade which shall evaluate the economic interests of, and review ways to strengthen the relationship between, the commonwealth and the Republic of Ireland. The commission shall study, research, analyze and make recommendations related to: (i) bilateral trade and investments between the commonwealth and the Republic of Ireland; (ii) policy issues of interest to the commonwealth; (iii) business and academic exchanges between the commonwealth and the Republic of Ireland; (iv) mutual economic support; (v) investments in the infrastructure of the commonwealth and the Republic of Ireland; (vi) the creation of economic and educational opportunities for aid to communities in the commonwealth and the Republic of Ireland; and (vii) other related issues as the commission deems necessary.

(b)(1) The commission shall consist of the following 15 members: 3 past or current members of the house of representatives, 2 of whom shall be appointed by the speaker of the house of representatives and 1 of whom shall be appointed by the minority leader of the house of representatives; 3 past or current members of the senate, 2 of whom shall be appointed by the president of the senate and 1 of whom shall be appointed by the minority leader of the senate; the state secretary or a designee; the secretary of economic development or a designee; the executive director of the Massachusetts office of international trade and investment; and 6 members appointed by the governor, 3 of whom shall be from institutions of higher education in the

commonwealth and 3 of whom shall be members of public organizations in the commonwealth promoting Irish American affairs. All commission members shall be persons with knowledge of, or current or past experience related to, Irish American affairs. Annually, the commission shall elect from among its members a chair, a vice chair, a treasurer and any other officers it deems necessary.

(2) The members of the commission shall receive no compensation for their services but shall be reimbursed for necessary traveling expenses incurred in the performance of their duties.

(c) The commission shall hold meetings at places it designates throughout the commonwealth, including diverse geographic locations.

(d) A majority of the members of the commission shall constitute a quorum for the transaction of business of the commission.

(e) Annually, not later than August 31, the commission shall submit a report of its findings, together with recommendations for any legislation, to the governor, the clerks of the house of representatives and the senate and the chairs of the joint committee on economic development and emerging technologies.

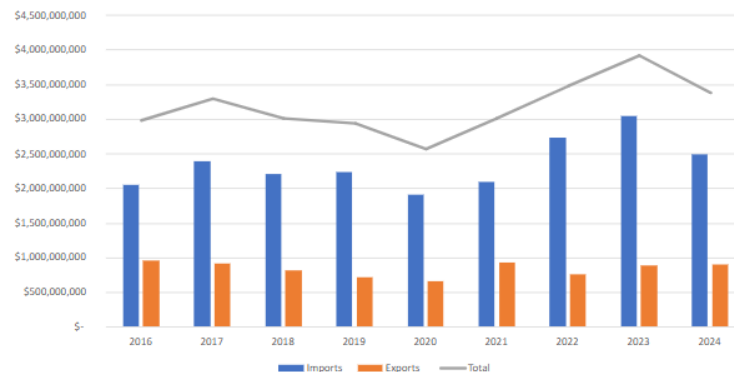
