These online certificates will have affixed to them the Massachusetts State Seal with a unique certificate number as well as the state website address (<http://corp.sec.state.ma.us/corp/Certificates/Verify.asp>) where the unique certificate number may be verified for authenticity.

At this time verification by the Registry Districts is not required.
