Water Management Act MGL c. 21G 310 CMR 36.00

The "Act" was passed in December 1985 and provided for a recognition of existing withdrawals through the filing of a Registration Statement.

Registration Statements must at a minimum contain:

- 1. The use for which the water is being withdrawn
- 2. Identification of the water source (in sufficient detail) from which the withdrawal is being made
- 3. Location of the withdrawal
- 4. Volume of the withdrawal, including seasonal variation
- 5. Conservation measures instituted, or to be instituted
- The point or points of where the water will be discharged after use

WMA: Registration Statements

Registrations

- Water rights based on prior use (1981-1985)
 - Sources
 - Average daily use (mgd)
 - Average annual use (mgy)
- Minimal conditions without regulation change
 - Meter sources (Agricultural exemptions)
 - Calibrate meters
 - Annual Reporting
- Normal Variation* may be recognized
- Not subject to Safe Yield limitation (*Normal variation is subject to safe yield considerations)

Registration History- Part 1

- Registration Statements have a 10 year term
 - Renewable if requested 6 months prior to the expiration date on forms provided by the Department
- PWS Renewals in 2007 included conditions requiring:
 - Meet 65/10 Performance Standards by 12/31/17
 - Compliance plans for those exceeding 80/15 beginning with 2009 ASR
 - Compliance plans for those exceeding 65/10 beginning with 2012 ASR
 - Implement Water Use Restrictions
 - <65 according to their Seasonal Plan at Drought Advisory or greater
 - ≥66 One day per week outside of 9 5 pm at Drought Advisory or greater

Registration History- Part 2

- The decision of the MA SJC in <u>Fairhaven</u>, et al v. <u>DEP</u>, 455 Mass. 740 (2010), as corrected and amended, required MassDEP to first promulgate regulations before including new conditions in registration renewals.
- Minimum "Registration Conditions" set out in 310 CMR 36.08 (as authorized by G.L. c. 21G, s. 6) were not challenged in <u>Fairhaven</u> and therefore continue to apply and be subject to enforcement.
 - meter
 - calibrate meter
 - maintain records and report withdrawal data

WMA: Permits

Permits

- Those who failed to register, new sources, or additional volumes after registration period
- 20-year renewal on basin schedule with periodic reviews
- Subject to impact review and conditions, including
 - Efficiency Requirements
 - 65 residential gallons per capita day (RGPCD)
 - 10% unaccounted-for-water (UAW)
 - BMPs (leak detection & repair, metering, pricing, public education etc.)
 - Seasonal Limits on nonessential outside water use
 - Operational limitations and/or monitoring of individual sources
 - Cold Water Fishery
 - Minimization
 - Mitigation
- Cannot permit volumes that exceed Safe Yield

Nonessential Outdoor Water Use Restrictions

Non-Essential: Uses not required for health or safety reasons, by regulation, for production of food or fiber, for maintenance of livestock, or to meet the core function of a business



- While permitted volumes represent 14% of the total PWS volumes allocated, the Performance Standards and other conservation conditions are applied to 46% of the water allocated because of permits.
- For 2015 the average RGPCD and UAW values were:
 - 59 and 17% for Registered Only Systems
 - 57 and 13% for those with a Permit
