






25% Design Plans – Key Plan
























- Temporary daily traffic set ups






How will bicyclists and pedestrians be impacted?

Bicycle and Pedestrian Impacts

- Existing stone dust portion of path to be closed during construction
- No access to corridor from Eversource Driveway to Route 20
- Temporary detours at intersections for sidewalk and ramp installation

How will your property be impacted?

Property Impacts

- Three (3) Temporary Easements
 - Eversource
 - Russell's Greenhouse
 - Town of Wayland
- Abutter and property access is required to be maintained by the contractor at all times for the duration of the project



Right of Way (ROW) discussion – 25% Design

- The Department of Conservation and Recreation (DCR) is responsible for acquiring all necessary rights in public land for design, construction, and implementation of a project.
- Affected property owners will be contacted by personnel from the ROW Bureau or consultants representing DCR.
- Procedures must comply with state and federal regulations governing the acquisition process.
 - Property owners are protected under Massachusetts General Laws, primarily Chapter 79.
 - If project receives federal funds, property owners are further protected under Title III of the Real Property Act of 1970, as amended.
- Temporary construction easements will be required.



Project Cost & Funding

- Current/Preliminary Estimate Total Construction Costs ~ \$4,000,000
- Programming the Project in the Statewide Transportation Improvement Program (STIP/TIP)
- Federal Funding by Federal Highway Administration & MassDOT

Minimal disruption to vehicular travel; with the exception of the area near the existing traffic signal where the proposed shared use path crosses Route 20. Benefit of connecting the shared use path currently under construction in the Town of Sudbury to the existing trail in the Town of Wayland.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed rail-to-trail project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The proposed project consists of approximately two (2) miles of a ten foot (10') wide shared use path along the existing MBTA Railroad Right of Way. The project will extend from the Eversource substation driveway on Route 20 to the Wayland Library (Route 27/126). The project also consists of the rehabilitation the existing timber trestle bridge over the Sudbury River to accommodate non-vehicular travelers.

Secure right-of-way easements are necessary for this project. Acquisitions in fee and permanent easements may be required. The Department of Conservation & Recreation (DCR) is responsible for acquiring all needed rights in private or public lands. MassDOT policy concerning land acquisitions will be presented in the hearing.
