A Live Virtual Design Public Hearing will be hosted on the MassDOT website below to present the design for the proposed **Norwottuck Rail Trail Resurfacing** project in **Amherst and Belchertown**, MA.

WHEN: 7:00 PM Thursday, November 18, 2021

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed **Norwottuck Rail Trail Resurfacing** project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The proposed project consists of rehabilitating a 1.5 mile segment of the Norwottuck Rail Trail (also known as the Massachusetts Central Rail Trail). The paved surface was originally constructed in 1997. The pavement surface is cracked and deteriorating in many places and reaching the end of its planned life. There are also several root-damaged areas and edge drop-offs which pose significant safety concerns for people walking and people biking. Improvements to the Warren Wright Parking Area are also planned.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The **Department of Conservation and Recreation** is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be presented in the hearing.

#### WHAT IS A PUBLIC HEARING?

#### WHY A PUBLIC HEARING?

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

#### WHY NOT A VOTE ON HIGHWAY PLANS?

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

#### WHAT DOES A PUBLIC HEARING ACCOMPLISH?

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

#### RIGHT OF WAY CONCERNS

Your Municipality is responsible for securing the right of way for this project. If your property, or a portion of it, must be acquired by the Municipality for highway purposes in the interest of all people of the Commonwealth, your rights are fully protected under the law. Briefly, here are some of the answers to questions you might ask.

#### 1. REASON FOR PROJECT

The completion of this project will serve local needs. The proposed enhancement will also be in the interest of others in the greater community, and provide for the public good.

#### 2. WHO CONTACTS ME?

Representatives of the municipality have already contacted or will contact you. They will explain the procedures used in acquiring any necessary rights in land.

#### 3. WHAT ABOUT DONATIONS? WHAT IS A RIGHT OF ENTRY?

Town officials will often seek donations, of parcels, where permanent rights are required. This procedure will minimize the acquisition cost for your community.

A Right of Entry is a document that is signed by the owner. It allows the Contractor to perform certain types of work on the owner's land. The work is usually minor in nature and frequently consists of loaming/seeding behind sidewalks, new driveway apron work, grading/sloping, and wetland protection, etc. The rights granted are temporary in nature.

#### 4. WHAT IS A FAIR PRICE FOR THE ACQUIRED PARCELS?

In the event that donations are not considered, or completed, every effort will be made to ensure that an equitable value is awarded. Municipal and/or outside appraisers will complete an appraisal. Consideration is given to the type of rights needed, whether in fee, permanent or temporary easements. The appraisal will be the basis for arriving at a fair price (for damages that result).

#### 5. MUST I ACCEPT THE MUNICIPALITY OFFER?

No, if the owner feels that the offer is not fair the owner may petition the courts. This action does not stop or delay the acquisition. The action must occur within 3 years. The owner(s) may be paid pro tanto (for the time being). The pro tanto payment will not prejudice the court's final decision.

### MCRT – Norwottuck Rail Trail Project in Amherst & Belchertown

#### **PROJECT LOCATION**

The Massachusetts Department of Transportation – Highway Division (MassDOT) in coordination with the Massachusetts Department of Conservation and Recreation (DCR) is proposing to resurface and rehabilitate a section of existing shared-use path in Amherst and Belchertown, MA. The route follows the former railroad right-of-way from Station Road in Amherst southeast to Warren Wright Road in Belchertown. The total project length is approximately 1.5 miles comprised of off-road trail.

#### PROPOSED IMPROVEMENTS

This project seeks to improve the safety of bicycle and pedestrian movements by rehabilitating the existing trail surface to eliminate pavement cracking, root damage and improve accessibility along this section of the shared-use path. In recent years, DCR and MassDOT have worked together to improve various sections of the MCRT. Other improvements include widening the existing 8-ft section to a 10-ft width, repairing and cleaning existing culverts, seeding the shoulders along each edge of the trail, and formalizing the parking and trailhead area at Warren Wright Road.

#### **RIGHT OF WAY IMPACTS**

The existing path follows the former railroad right of way currently under municipal ownership with maintenance provided by the DCR. MassDOT's policy regarding land acquisitions will be discussed at the meeting.

#### **ENVIRONMENTAL IMPACTS**

The proposed project has been designed to avoid and minimize impacts to adjacent resource areas. A Notice of Intent application will be filed with the Amherst Conservation Commission for the proposed work occurring within wetland resource areas.

#### MAINTENANCE OF TRAFFIC DURING CONSTRUCTION

It is the intent of this project that all cross streets remain open to traffic at all times during construction. However, this section of trail will need to be closed during construction activities.

#### **PROJECT COST**

The project construction cost is estimated to be approximately \$1.5 million and will be funded using a combination of State and Federal funds.

#### **PROJECT SCHEDULE**

This project has been programmed in the Statewide Transportation Improvement Program for Federal Fiscal Year 2022. The design plans displayed at this meeting are at the 25% Design Stage of completion (Preliminary Design Stage). Comments made at this public meeting will be reviewed and considered to the maximum extent possible.

#### FREQUENTLY ASKED QUESTIONS

Q: Will my commute via motor vehicle on area roadways be impacted?

A: No – cross streets are intended to remain open during construction.

Q: Will my trip on the Norwottuck be impacted?

A: We do anticipate that the trail itself will need to be closed during paving operations. Any trail closures will be posted in advance.

Q: Who will own this – DCR, MassDOT, or the Towns?

A: Portions of the trail are currently owned by the Department of Conservation and Recreation (DCR) and portions are owned by the Town of Amherst. It is intended that the portions of trail under Town of Amherst ownership will be either transferred to DCR, or the DCR and Town will enter into a long-term maintenance agreement. MassDOT is administering the design and construction oversight.

Q: Will my private property be impacted?

A: No impacts to private property are proposed at this time.

Q: The hearing notice says comments must be received within ten days of the hearing – if I have a comment after ten days, does that mean you won't look at it?

A: All comments will be reviewed at all stages of design – the ten day time limit is the cutoff for comments to be included in the formal meeting transcript.
