A Design Public Hearing Meeting will be held by MassDOT to discuss the proposed Highway Reconstruction of Route 68 (Main Street) project in Hubbardston, MA.

**PURPOSE**: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed Highway Reconstruction of Route 68 (Main Street) project. All views and comments made at the hearing will be reviewed and considered to the maximum extent possible.

**PROPOSAL**: The proposed project consists of Highway Reconstruction of Route 68 (Main Street) from 1'000 ft North of Williamsville Road to Elm Street. The work includes roadway reclamation, sidewalk construction and reconstruction, replacing a flashing beacon, minor drainage improvements and related work. Shared use accommodations consisting of a 10ft wide Shared Use Path (South Side) and 5ft wide Bike Lane (North Side) have been provided in accordance with applicable design guides.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The Town of Hubbardston is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be discussed at this hearing.

Written views received by MassDOT subsequent to the date of this notice and up to five (5) days prior to the date of the hearing shall be displayed for public inspection and copying at the time and date listed above. Plans will be on display one-half hour before the hearing begins, with an engineer in attendance to answer questions regarding this project. A project handout will be made available on the MassDOT website listed below.

Written statements and other exhibits in place of, or in addition to, oral statements made at the Public Hearing Meeting regarding the proposed undertaking are to be submitted to Patricia A. Leavenworth, P.E., Chief Engineer, MassDOT, 10 Park Plaza, Boston, MA 02116, Attention: **Roadway Project Management,** Project File No. **608793**. Such submissions will also be accepted at the hearing. Mailed statements and exhibits intended for inclusion in the public hearing transcript must be postmarked no later than ten (10) business days after this Public Hearing Meeting. #### WHAT IS A PUBLIC HEARING?

#### WHY A PUBLIC HEARING?

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

#### WHY NOT A VOTE ON HIGHWAY PLANS?

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

#### WHAT DOES A PUBLIC HEARING ACCOMPLISH?

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

#### **RIGHT OF WAY ISSUES**

A secure right of way is necessary for this project. Temporary construction easements may be required. Your *municipality* is responsible for acquiring all necessary rights in private or public lands. If your property is affected, your rights are fully protected under law.

#### 1. REASON FOR PROJECT

The completion of this project will serve local needs. The proposed enhancement will also be in the interest of others in the greater community, and provide for the public good.

#### 2. WHO CONTACTS ME?

Representatives of the municipality have already contacted or will contact you. They will explain the procedures used in acquiring any necessary rights in land.

#### 3. WHAT ABOUT DONATIONS? WHAT IS A RIGHT OF ENTRY?

Town officials will often seek donations, of parcels, where permanent rights are required. This procedure will minimize the acquisition cost for your community.

A Right of Entry is a document that is signed by the owner. It allows the Contractor to perform certain types of work on the owner's land. The work is usually minor in nature and frequently consists of loaming/seeding behind sidewalks, new driveway apron work, grading/sloping, and wetland protection, etc. The rights granted are temporary in nature.

#### 4. WHAT IS A FAIR PRICE FOR THE ACQUIRED PARCELS?

In the event that donations are not considered, or completed, every effort will be made to ensure that an equitable value is awarded. Municipal and/or outside appraisers will complete an appraisal. Consideration is given to the type of rights needed, whether in fee, permanent or temporary easements. The appraisal will be the basis for arriving at a fair price (for damages that result).

#### 5. MUST I ACCEPT THE MUNICIPALITY OFFER?

No, if the owner feels that the offer is not fair the owner may petition the courts. This action does not stop or delay the acquisition. The action must occur within 3 years. The owner(s) may be paid pro tanto (for the time being). The pro tanto payment will not prejudice the court's final decision.

#### **PROJECT DESCRIPTION**

#### PROJECT LOCATION AND PURPOSE

The purpose of this project is to increase safety for all modes of transportation and improve roadway operation. The Massachusetts Department of Transportation (MassDOT) and the Town of Hubbardston are proposing pedestrian, bicyclist, and vehicular safety and mobility improvements along approximately 4,100 feet of Route 68 (Main Street). This proposed project is intended to improve the safety and accessibility for pedestrians and bicyclists, and to improve safety and operations related to vehicles heading to/from Route 2 and Worcester. The attached Locus Map shows the project location.

#### PROPOSED IMPROVEMENTS

The proposed improvements along Main Street (Route 68) between the Curtis Recreational Field and Brigham Street include:

- Mill and overlay of Main Street (Route 68) from the Curtis Recreational Field to Williamsville Road;
- Full Depth roadway reconstruction of Main Street (Route 68) and side street approaches from Williamsville Road to Elm Street
- Installation of a shared-use path with a grass buffer southerly side of Main Street (Route 68). The proposed shared-use path and grass buffer shift to the north side of Main Street (Route 68) for the final 500' approach to the Curtis Recreational Field;
- Sidewalk installation adjacent to the roadway on the opposite side of Main Street (Route 68) from the shared use path within the project limits;
- Striping of a 5-foot bicycle lane with appropriate signage along the sidewalk side (non-shared use path side) of Main Street (Route 68) within the project limits;
- Installation of new MUTCD-compliant traffic signage and pavement markings along Main Street (Route 68) within the project limits;
- Installation of Rectangular Rapid Flashing Beacons (RRFB) at the proposed crosswalk locations on Main Street (Route 68);
- Construction of a pedestrian refuge island at the Main Street (Route 68) / High Street intersection;
- Construction of Americans with Disabilities Act (ADA) / Architectural Access Board (AAB) accessible wheelchair ramps along Main Street (Route 68) within the project limits;
- Striping for on-street parking along Main Street (Route 68) in front of the Hubbardston Center School; and
- Realignment of the High Street / Main Street (Route 68) and Williamsville Road / Main Street (Route 68) intersections.

#### TRAFFIC MANAGEMENT

During typical construction operations, all roadways in the project area will remain open to residents and other traffic. Occasional short traffic disruptions and travel lane/shoulder/parking lane closures may occur, but every effort will be made to minimize inconvenience to the travelling public and abutting residents and businesses. Pedestrian and vehicular access to abutting properties will be maintained throughout construction.

#### **RIGHT OF WAY IMPACTS**


The Town of Hubbardston has an available public right-of-way approximately 66 feet along the Main Street corridor, which will accommodate the majority of this project. Temporary construction easements will be required for grading impacts to lawns, driveways, and walkways and to restore impacts to adjacent properties. Small permanent easements will also be required for utility pole relocations. The Town of Hubbardston will be responsible for securing all necessary easements. MassDOT's policy concerning land acquisition will be discussed at this hearing.

#### **PROJECT COST**

The current estimate of the total construction cost of this project is approximately \$4.9 Million

#### PROJECT SCHEDULE

The design plans presented this evening are at the 25% design stage. Design, permitting and right of way acquisition must be completed by January 2023. Construction is anticipated to begin in the Fall of 2023.
