A Live Virtual Design Public Hearing will be hosted on the MassDOT website below to present the design for the proposed Brayton Elementary School Improvements (SRTS) project in North Adams, MA.

WHEN: 7:00 PM, Tuesday, August 3, 2021

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted

with the proposed Brayton Elementary School Improvements (SRTS) project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum

extent possible.

PROPOSAL: The proposed project consists of installing and repairing 1,500 linear feet of sidewalk along

Brayton Hill Terrace and along Brickyard Court to improve pedestrian access, connectivity, and safety and create the appropriate infrastructure for students walking. Pedestrian access and ADA-compliance will be achieved by reducing the slope of the sidewalks where feasible and striping existing and new crosswalks. Crosswalk visibility will be enhanced through the installation of pedestrian-activated rectangular rapid flashing beacons (RRFBs). A five-foot-wide bicycle lane will be striped along Brayton Hill Terrace between its intersections with Brickyard Court and

with Brayton Street in each direction of travel.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The City is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be presented in the hearing.

WHAT IS A PUBLIC HEARING?

WHY A PUBLIC HEARING?

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

WHY NOT A VOTE ON HIGHWAY PLANS?

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

WHAT DOES A PUBLIC HEARING ACCOMPLISH?

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

RIGHT OF WAY CONCERNS

Your Municipality is responsible for securing the right of way for this project. If your property, or a portion of it, must be acquired by the Municipality for highway purposes in the interest of all people of the Commonwealth, your rights are fully protected under the law. Briefly, here are some of the answers to questions you might ask.

1. REASON FOR PROJECT

The completion of this project will serve local needs. The proposed enhancement will also be in the interest of others in the greater community, and provide for the public good.

2. WHO CONTACTS ME?

Representatives of the municipality have already contacted or will contact you. They will explain the procedures used in acquiring any necessary rights in land.

3. WHAT ABOUT DONATIONS? WHAT IS A RIGHT OF ENTRY?

Town officials will often seek donations, of parcels, where permanent rights are required. This procedure will minimize the acquisition cost for your community.


A Right of Entry is a document that is signed by the owner. It allows the Contractor to perform certain types of work on the owner's land. The work is usually minor in nature and frequently consists of loaming/seeding behind sidewalks, new driveway apron work, grading/sloping, and wetland protection, etc. The rights granted are temporary in nature.

4. WHAT IS A FAIR PRICE FOR THE ACQUIRED PARCELS?

In the event that donations are not considered, or completed, every effort will be made to ensure that an equitable value is awarded. Municipal and/or outside appraisers will complete an appraisal. Consideration is given to the type of rights needed, whether in fee, permanent or temporary easements. The appraisal will be the basis for arriving at a fair price (for damages that result).

5. MUST I ACCEPT THE MUNICIPALITY OFFER?

No, if the owner feels that the offer is not fair the owner may petition the courts. This action does not stop or delay the acquisition. The action must occur within 3 years. The owner(s) may be paid pro tanto (for the time being). The pro tanto payment will not prejudice the court's final decision.



Safe Routes to School Infrastructure Program Brayton Elementary School Infrastructure Improvements (Route 2 / Brayton Hill Terrace / Brickyard Court / School Driveway) North Adams, MA

PROJECT LOCATION

The project includes traffic, bicycle, and pedestrian safety improvements along portions of Mohawk Trail (Route 2), Brayton Hill Terrace, Brickyard Court, and the School/YMCA rear driveway accessing Brickyard Court, all of which are associated with the Brayton Elementary School Improvements in North Adams, MA. The attached Locus Map outlines the project location.

PROJECT PURPOSE

The Massachusetts Department of Transportation (MassDOT) and the City of North Adams are proposing traffic, bicycle, and pedestrian safety improvements in segments along approximately 900 feet of Brayton Hill Terrace between Mohawk Trail (Route 2) and the Brayton Hill Apartments; approximately 220 feet of new sidewalks on each side of Brickyard Court between Brayton Hill Terrace and the rear Brayton Elementary School driveway; and reconstruction of the rear Brayton Elementary School driveway to introduce a new sidewalk connection to the school building. The project will also include upgrades to the existing crosswalks. This proposed project is primarily intended to improve the safety and accessibility for pedestrians from the surrounding neighborhoods to the Brayton Elementary School.

PROPOSED IMPROVEMENTS

The project includes pedestrian and bicycle safety improvements along segments of the two area roadways. The proposed improvements include:

- Brayton Hill Terrace construct approx. 550 feet of new 5-foot wide cement concrete sidewalk with 6-inch granite curbing along the east side of the roadway. The project will also include a new flashing pedestrian warning device at a relocated crosswalk in the vicinity of Brayton Street. The sidewalk work as part of this project will meet the sidewalks that were constructed by the City of North Adams in mid-2020. Additionally, the project will include the application of new bicycle lane markings along the roadway between Brickyard Court and Brayton Street, just south of the signalized intersection at Route 2.
- **Brickyard Court** construct approximately 220 feet of new 5-foot wide cement concrete sidewalks on each side of the roadway that will be separated from the roadway surface by a grass buffer. The project also includes resurfacing of the roadway while retaining the existing asphalt berms. Some existing utilities will be relocated in the vicinity of the school driveway. The project will also include a new flashing pedestrian warning device at a relocated crosswalk in the vicinity of the school driveway.

- Brayton Elementary School / YMCA Driveway relocate and reconstruct the existing rear school driveway where it meets Brickyard Court to reduce the slope of the driveway and introduce approximately 50 feet of a new 5-foot wide cement concrete sidewalk connection between Brickyard Court and the sidewalk adjacent to the school building.
- Mohawk Trail (Route 2) / Brayton Hill Terrace Intersection reconstruct existing
 accessible ramps, reapply crosswalk pavement markings, and retrofit the existing traffic
 signal with new ADA-compliant pushbuttons to activate the pedestrian phase.
- **General** construct new Americans with Disabilities Act (ADA) / Architectural Access Board (AAB)-compliant accessible curb ramps within the various project limits.

TRAFFIC MANAGEMENT

During typical construction operations, all roadways in the project area will remain open to residents and other traffic. Occasional short traffic disruptions and travel lane/shoulder closures may occur, but every effort will be made to minimize inconvenience to the travelling public and abutting residents and businesses. Pedestrian and vehicular access to abutting properties will be maintained throughout construction.

RIGHT OF WAY IMPACTS

Temporary construction easements will be required for minor grading impacts to lawns, driveways, and walkways; and to restore features on adjacent properties. Small permanent easements will also be required to position the constructed sidewalks and related improvements within publicly-owned or -controlled property. The City of North Adams will be responsible for securing all necessary easements. MassDOT's policy concerning land acquisition will be discussed at this hearing.

PROJECT COST

The current estimate of the total construction cost of this project is approximately \$738,000 using a combination of Federal and State funding sources. The City of North Adams is responsible for all costs associated with the acquisition of temporary and permanent easements.

PROJECT SCHEDULE

The design plans presented this evening are at the 25% design stage. Design, permitting and right-of-way acquisition must be completed by Summer 2022. Construction is anticipated to begin in Spring 2023.
