NOTICE OF A DESIGN PUBLIC HEARING**

**Project Description: Pittsfield – Bridge Replacement, Br# P-10-003 & P-10-032, South Street (US 20/7)  
over Housatonic Railroad, Housatonic River  
Project File No. 612498**

A Design Public Hearing will be held to present the design for the proposed project in Pittsfield, MA.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The proposed project consists of the full replacement of two bridges in Pittsfield, Massachusetts: Bridge No. P-10-003, which spans the Housatonic Railroad, and Bridge No. P-10-032, which crosses the Housatonic River. The roadway, South Street (US 20/7), will be widened to accommodate the new bridge widths and include buffered bike lanes, pedestrian sidewalks, and a two-way continuous center turn lane.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The Commonwealth of Massachusetts is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be presented in the hearing.

## **WHAT IS A PUBLIC HEARING?**

### **WHY A PUBLIC HEARING?**

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

### **WHY NOT A VOTE ON HIGHWAY PLANS?**

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

### **WHAT DOES A PUBLIC HEARING ACCOMPLISH?**

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

## **RIGHT OF WAY CONCERNS**

The State is responsible for securing the Right of Way for this project. If your property, or a portion of it, must be acquired by the State for highway purposes in the interest of all people of the Commonwealth, your rights are fully protected under the law. Briefly, here are some of the answers to questions you might ask.

### **1. WHO CONTACTS ME?**

Representatives of the Right of Way Bureau of the Massachusetts Department of Transportation's Highway Division. They will explain the impacts and your rights as protected under Massachusetts General Laws Chapter 79.

### **2. WHAT IS A FAIR PRICE FOR MY PROPERTY?**

Every offer is made to ensure that an equitable value is awarded to you for the property, or to appraise the "damage" to the property as a result of the acquisition. MassDOT appraisers, independent appraisers, MassDOT "Review Appraisers" and a Real Estate Appraisal Review Board may all contribute in arriving at an award of damages. The State also pays a proportionate part of the real estate tax for the current year for fee takings, and interest from the date the property is acquired to the payment date, on all impacts.

### **3. MUST I ACCEPT THE DEPARTMENT'S OFFER?**

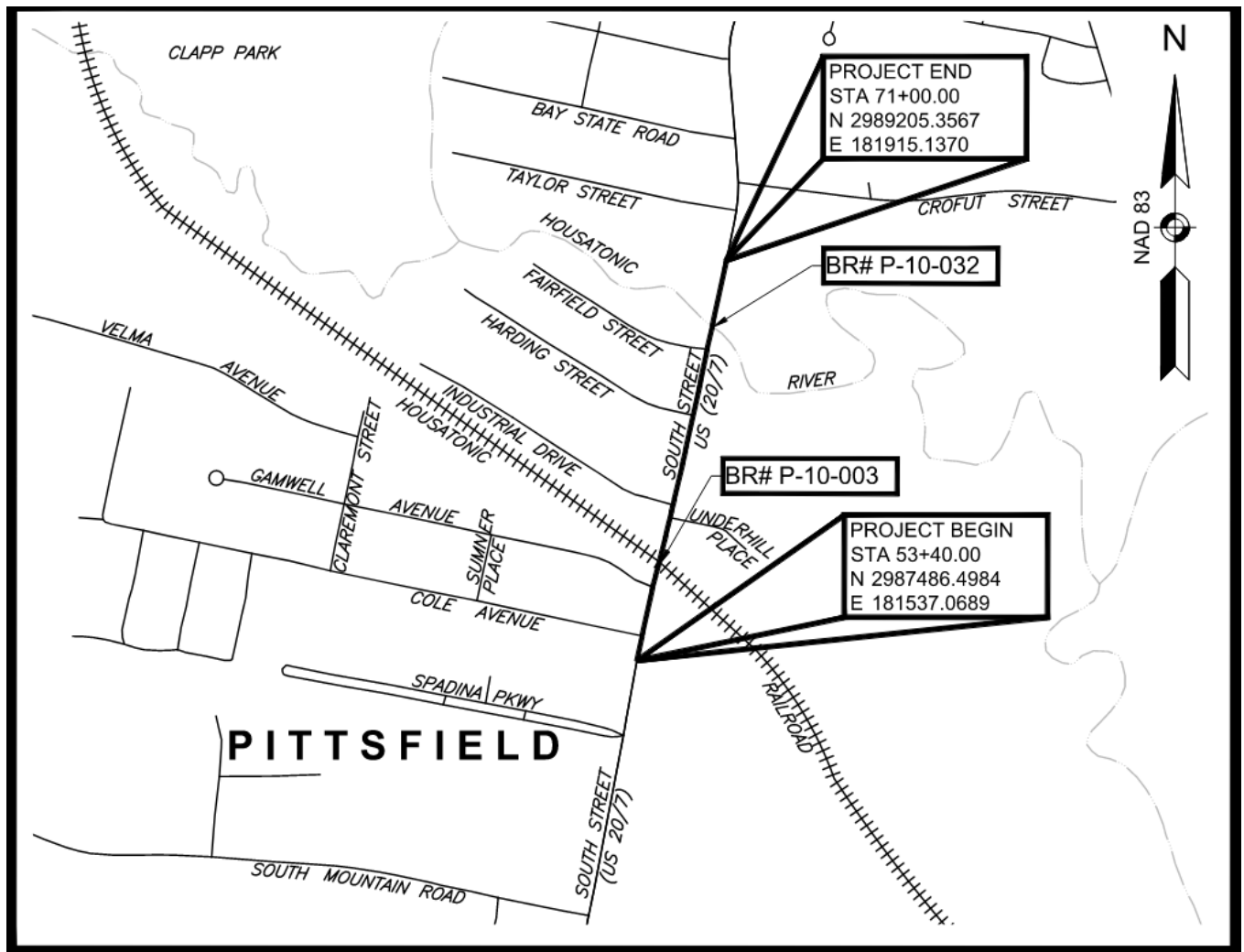
No. If, after the figure established as market value has been offered to the owner, the owner feels he or she is not being offered a fair price, he or she has the right, within three years, to appeal to the courts. Pending a court decision, he or she can be paid on a "pro-tanto" basis (or "for the time being") that in no way prejudices the court appeal.

### **4. WHAT WILL HAPPEN TO MY HOUSE?**

The owner will have the opportunity to buy back his or her house, provided he or she has a location to which it can be moved, and the proper permits for its removal. If the owner does not wish to repurchase, the house will be advertised for bids. The highest bidder, who must also have a location and permits for removal, will be awarded the house. Otherwise, the structure will be slated for demolition.

### **5. WHAT HAPPENS IF I MUST RELOCATE?**

In addition to the market value of the property, the Department pays certain relocation benefits for both owners and tenants of acquired residences and businesses who meet eligibility requirements. Assistance in relocation is also provided. Department brochures are available for details on these benefits.

**PROPOSED IMPROVEMENTS**

**Purpose of the Project**

MassDOT has retained CHA Consulting, Inc. to provide professional engineering services required for the bridge replacements of existing Bridge Nos. P-10-003 and P-10-032, which carry South Street (US 20/7) over the Housatonic Railroad and the Housatonic River in Pittsfield, Massachusetts.

The purpose of the project is to replace two structurally deteriorated bridges with new bridges along a similar horizontal and vertical alignment.

**Project Location and Limits**

The project is located on South Street (US 20/7) with limits from the Cole Avenue intersection to just south of Taylor Street in Pittsfield, Massachusetts. The total project length is approximately 1,760 feet. The attached locus map shows the location of the project.

**Features of the Project**

The proposed project consists of demolition of the existing bridges, installation of two new bridges and roadway reconstruction. The new bridges will carry 2-11' travel lanes, 2-5' shoulders/bike lanes with 2' buffers, and 2-5' wide minimum sidewalks. Bridge No. P-10-003 will be comprised of PCI Northeast Solid Deck Beams with metal S3-MTL4 bridge rail and Type I Protective Screen. Bridge No. P-10-032 will be comprised of prestressed NEDBT40 beams with metal S3-MTL4 bridge rail. Roadway improvements will include widening, milling and overlay, full depth roadway reconstruction, sidewalk reconstruction, new guardrail, installation of accessible pedestrian signals (APS) at the Gamwell intersection, and street lighting updates. Additional work for construction will include utility relocations and erosion control.

**Land Acquisition (Right of Way Impacts)**

Temporary and permanent easements and fee takings will be required for the project.

**Maintenance of Traffic During Construction**

Throughout construction, one lane of traffic in each direction will remain open. Pedestrian accommodation during construction will be achieved with temporary pedestrian bridges at both bridges located on the west side. A short-term detour may be used to facilitate construction for select activities such as beam unloading and placement, temporary bridge unloading, and paving. The proposed detour route is approximately 6 miles long and would utilize Holmes Road, Pomeroy Avenue, and Crofut Street.

**Environmental and Historical Impacts**

Environmental permits will be required for the construction of the bridge. Both bridges are not historically registered.

**Project Status and Schedule**

The plans on display tonight are at the preliminary 25% design stage. Comments received this evening will be considered in determining the final design. Construction is anticipated to begin in the year 2027.

**Project Cost**

The estimated construction cost of this project is approximately \$18,500,000.
