A Virtual Design Public Hearing will be hosted on the MassDOT website below to present the design for the proposed project in Raynham and Taunton, MA.

WHEN: 6:00 PM, Wednesday, July 30, 2025

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The proposed project consists of replacing the bridge deck, increasing safety, and improving operations of the roadway. The proposed design relocates the existing bridge sidewalk from the east to the west side of the bridge to connect to an existing sidewalk on the southwest approach. A 5-foot shoulder for a bike lane in the northbound direction improves safety by providing dedicated space for cyclists, separating them from vehicular traffic. This separation reduces the risk of conflicts between cyclists and vehicles.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The municipality is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be presented in the hearing.

WHAT IS A PUBLIC HEARING?

WHY A PUBLIC HEARING?

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

WHY NOT A VOTE ON HIGHWAY PLANS?

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

WHAT DOES A PUBLIC HEARING ACCOMPLISH?

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

RIGHT OF WAY CONCERNS

Your Municipality is responsible for securing the right of way for this project. If your property, or a portion of it, must be acquired by the Municipality for highway purposes in the interest of all people of the Commonwealth, your rights are fully protected under the law. Briefly, here are some of the answers to questions you might ask.

1. REASON FOR PROJECT

The completion of this project will serve local needs. The proposed enhancement will also be in the interest of others in the greater community, and provide for the public good.

2. WHO CONTACTS ME?

Representatives of the municipality have already contacted or will contact you. They will explain the procedures used in acquiring any necessary rights in land.

3. WHAT ABOUT DONATIONS? WHAT IS A RIGHT OF ENTRY?

Town officials will often seek donations, of parcels, where permanent rights are required. This procedure will minimize the acquisition cost for your community.


A Right of Entry is a document that is signed by the owner. It allows the Contractor to perform certain types of work on the owner's land. The work is usually minor in nature and frequently consists of loaming/seeding behind sidewalks, new driveway apron work, grading/sloping, and wetland protection, etc. The rights granted are temporary in nature.

4. WHAT IS A FAIR PRICE FOR THE ACQUIRED PARCELS?

In the event that donations are not considered, or completed, every effort will be made to ensure that an equitable value is awarded. Municipal and/or outside appraisers will complete an appraisal. Consideration is given to the type of rights needed, whether in fee, permanent or temporary easements. The appraisal will be the basis for arriving at a fair price (for damages that result).

5. MUST I ACCEPT THE MUNICIPALITY OFFER?

No, if the owner feels that the offer is not fair the owner may petition the courts. This action does not stop or delay the acquisition. The action must occur within 3 years. The owner(s) may be paid pro tanto (for the time being). The pro tanto payment will not prejudice the court's final decision.

PROPOSED IMPROVEMENTS

PROPOSED IMPROVEMENTS

Proposed improvements are focused on rehabilitating the structurally deficient bridge, increasing safety, and improving operations of the roadway. The bridge work will consist of superstructure replacement for this project. Existing abutments and pier will be modified to accept the replacement superstructure and undergo minor repairs as needed. The proposed improvements are as follows:

- Superstructure replacement
 - The replacement superstructure will consist of six steel beams and a reinforced concrete deck slab. The sidewalk will be moved from the east side of the bridge to the west side of the bridge to provide connectivity with an existing approach sidewalk south of the bridge. The new two-span bridge will support a 6-foot sidewalk and a 27-foot-wide roadway consisting of two 10-foot travel lanes with a 2' shoulder on the sidewalk side and a 5' bike lane on the safety curb side.
- Approach roadway work
 - This includes full depth pavement reconstruction with milling and paving of approximately 200 feet of roadway both south of the bridge and approximately 450 feet of roadway north of the bridge. The sidewalk will be extended north to the intersection with Sandy Hill Street. The roadway will be widened by one foot to allow for a 5-foot bike lane on the west side of the bridge.
- Utility relocation
 - The project will require the relocation of the existing utilities. Prior to construction, overhead wires will be relocated from the west side of the roadway to beyond the east side of the roadway to provide room for construction equipment. The bridge currently carries gas and sewer mains supported by the steel beams under the east side of the bridge. Those utilities will be moved to a new utility bay beneath the new sidewalk on the west side of the bridge. Construction of the superstructure will be staged to allow for continuous service of the gas and sewer mains during construction.

This project is anticipated to be advertised for construction in late Summer 2026.
