NOTICE OF A DESIGN PUBLIC HEARING

Spencer - East Brookfield - Intersection Improvements at Route 9 and Route 49

A Design Public Hearing will be hosted on the MassDOT website below to present the design for the proposed project in Spencer - East Brookfield, MA.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The proposed project consists of improvements along Route 9 and at the intersection of Route 9 and Route 49 in the Towns of East Brookfield and Spencer. The work involves construction of a cement concrete roundabout, improved bike and pedestrian accommodations, lighting, and upgrades to pavement, drainage, pavement markings, and signage. The proposed pedestrian accommodations consist of 5-foot wide sidewalks along Route 9 and a shared use path at the roundabout. The proposed bicycle accommodations consist of 5-foot buffered bicycle lanes along Route 9 and a shared use path at the roundabout. Pedestrian and bicycle accommodations have been provided in accordance with applicable design guides.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The Commonwealth of Massachusetts is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be presented in the hearing.

WHAT IS A PUBLIC HEARING?

WHY A PUBLIC HEARING?

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

WHY NOT A VOTE ON HIGHWAY PLANS?

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

WHAT DOES A PUBLIC HEARING ACCOMPLISH?

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

RIGHT OF WAY CONCERNS

The State is responsible for securing the Right of Way for this project. If your property, or a portion of it, must be acquired by the State for highway purposes in the interest of all people of the Commonwealth, your rights are fully protected under the law. Briefly, here are some of the answers to questions you might ask.

1. WHO CONTACTS ME?

Representatives of the Right of Way Bureau of the Massachusetts Department of Transportation's Highway Division. They will explain the impacts and your rights as protected under Massachusetts General Laws Chapter 79.

2. WHAT IS A FAIR PRICE FOR MY PROPERTY?

Every offer is made to ensure that an equitable value is awarded to you for the property, or to appraise the "damage" to the property as a result of the acquisition. MassDOT appraisers, independent appraisers, MassDOT "Review Appraisers" and a Real Estate Appraisal Review Board may all contribute in arriving at an award of damages. The State also pays a proportionate part of the real estate tax for the current year for fee takings, and interest from the date the property is acquired to the payment date, on all impacts.

3. MUST I ACCEPT THE DEPARTMENT'S OFFER?

No. If, after the figure established as market value has been offered to the owner, the owner feels he or she is not being offered a fair price, he or she has the right, within three years, to appeal to the courts. Pending a court decision, he or she can be paid on a "pro-tanto" basis (or "for the time being") that in no way prejudices the court appeal.

4. WHAT WILL HAPPEN TO MY HOUSE?

The owner will have the opportunity to buy back his or her house, provided he or she has a location to which it can be moved, and the proper permits for its removal. If the owner does not wish to repurchase, the house will be advertised for bids. The highest bidder, who must also have a location and permits for removal, will be awarded the house. Otherwise, the structure will be slated for demolition.

5. WHAT HAPPENS IF I MUST RELOCATE?

In addition to the market value of the property, the Department pays certain relocation benefits for both owners and tenants of acquired residences and businesses who meet eligibility requirements. Assistance in relocation is also provided. Department brochures are available for details on these benefits.

Project Locus



Project Description

The Massachusetts Department of Transportation – Highway Division (MassDOT) is proposing the reconstruction of approximately 4,000 feet (0.75 mile) of Route 9 (West Main Street) and approximately 600 feet (0.11 mile) of Route 49 (Podunk Pike) in the towns of East Brookfield and Spencer, MA. The project involves roadway reconstruction, pavement rehabilitation, and geometric improvements to enhance safety and traffic operations.

Proposed Improvements

The proposed work includes construction of a hybrid cement concrete roundabout at the existing unsignalized intersection of Route 9 and Route 49, including a shared-use path and bicycle ramps on each approach. Additional work includes geometric modifications, pavement rehabilitation, and safety enhancements to improve conditions for pedestrians, bicyclists, and motorists. Buffered bicycle lanes will be provided along Route 9, and new sidewalks will ensure continuous pedestrian connectivity on both sides of the roadway. High-visibility crosswalks and a Rectangular Rapid Flashing Beacon (RRFB) will improve pedestrian and bicyclist crossings. Other enhancements include storm drain improvements, curb upgrades, sidewalks, guardrail upgrades, and sign and pavement marking improvements.

Existing Conditions

The project is located within the towns of East Brookfield and Spencer, MA. Route 9 is a state-maintained roadway classified as an Urban Principal Arterial. Route 9 provides one travel lane in each direction with variable shoulders, existing curbing, and limited pedestrian and bicycle accommodations. The Route 9/Route 49 intersection is unsignalized, with channelized turn lanes and medians, but no pedestrian or bicycle facilities. Pavement conditions range from fair to good, with localized cracking and utility patches. Land use along the corridor includes a mix of commercial, residential, and open space.

Right of Way Impacts

There are a few properties that will require temporary easements by MassDOT for grading, driveway reconstruction, sidewalks, loam and seed, erosion control, and clearing and grubbing. Permanent easements and Takings are not anticipated. MassDOT's policy regarding land acquisitions will be discussed at this hearing.

Maintenance of Traffic During Construction

The project is currently designed to keep all streets open to traffic during construction. Lane closures will be limited to off-peak periods. Traffic will be shifted around the work zones in stages at the Route 9/Route 49 intersection with appropriate traffic control measures in place. Driveway access for abutting properties will always be maintained, and temporary pedestrian ramps and detours will provide continuous accessible routes throughout the construction period. Detours and night work are not anticipated.

Project Status – Project Schedule

The project has been programmed in the Statewide Transportation Improvement Program for Federal Fiscal Year 2028. The Plans presented are at the 25% Design Stage.

Project Construction Cost

The project construction costs will be funded with a combination of money from the Federal Highway Administration and the Commonwealth of Massachusetts. The current project construction estimate is approximately \$12 million.
