




Why was this project initiated?

Existing Conditions

- **Sidewalks in Poor Condition**
 - Sidewalks and pedestrian curb ramps do not meet ADA standards
 - Sidewalk not continuous on Sconticut Neck Road
- **Missing Bicycle Accommodations**
 - Bicycle Accommodations Lacking from Phoenix Rail Trail to Leroy Wood School
- **Utility Poles Interfering with Pedestrian Travel**
 - Poles in Sidewalks Block Pedestrian Path
- **Excessively Wide Roadway**
 - Encourages Higher Speeds

Deteriorated Sidewalk Curb Reveal Lacking

Missing Bicycle Accommodations - No Marked Bicycle Lane from Phoenix Trail to School



Poles in Sidewalk Forces Pedestrians into the Roadway



Wide Expanse of Pavement - Encourages Higher Travel Speeds








Typical Roadway Cross Section

Preliminary Right of Way (ROW) discussion 25% Design Public Hearing

- The Town and MassDOT are responsible for acquiring all necessary rights in public land for design, construction, and implementation of this project.
 - Fee takings, permanent easements and/or temporary construction easements may be required.
- Affected property owners will be contacted by personnel from the Town or MassDOT's ROW Bureau (or consultants representing the responsible agency).
 - Property owners are protected under Massachusetts General Laws, primarily Chapter 79.
- Preliminary ROW drawings will be available at the Town of Fairhaven web site at <https://www.fairhaven-ma.gov/public-works-department> for public review and comment.


At this stage of design, the Right of Way process has not been finalized. This meeting is an opportunity for the public to comment on any impacts to properties.

- Early Environmental Coordination Checklist Submitted in February 2021
- NEPA - Categorical Exclusion Checklist submitted at 100% design.
- No Other Environmental Permitting Anticipated





Construction Approach Phased Construction

 Phase One - Roadway Widening and Sidewalk Construction

 Phase Two – Mill and Pave the Roadway

Message Boards will be placed in advance of project limits 14 days prior to the start of work


Phase One

Narrowed Road with Police Traffic Control During Construction Activity. Work is Performed Off of the Road.

Drums to be Placed During Off-Peak Hours.

Anticipated Duration 8 Months


The contractor will accommodate school hours of operation as best possible.



Phase Two

Roadway to be Closed with Temporary Detour. Traffic Restored to Normal Operation During Non-Working Hours.

Anticipated Duration 1 week.

ROW Costs are the Responsibility of the Municipality and State




