 - police details
 - utility relocation (as needed)
- TFPCC is 80% Federally Funded and 20% MassDOT Funded

Preliminary Right of Way (ROW) discussion – 25% Design


- The Town of Harwich is responsible for acquiring all necessary rights in public land for design, construction, and implementation of the project.
- Affected property owners will be contacted by personnel from the Town.
- Procedures must comply with state and federal regulations governing the acquisition process.
 - Property owners are protected under Massachusetts General Laws, primarily Chapter 79.
 - If project receives federal funds, property owners are further protected under Title III of the Real Property Act of 1970, as amended.
- Fee takings, permanent easements, and/or temporary construction easements may be required.
- For review of the plans, they will be made available at Town Hall.

Project Area

- 1,000' along South Street from School House Drive to the Main Street
- 2,100' along Main Street from South Street to Sisson Road
- 1,900' along Sisson Road from Main Street to School House Drive

Project Needs and Goals- Improve Sidewalks/Access

- Various narrow sections
- Missing detectable warning panels
- Sections with steep grades
- Incomplete sidewalk loop from/to School House Drive




Project Needs and Goals – Safer Pedestrian Crossings

- Crosswalks do not meet desire lines
- Sight line issues
- Many missing crosswalks and ramps



Project Needs and Goals – Bicycle Infrastructure


- Old Colony Rail Trail located just north of project limits, parallel to Main Street






South Street – Alternative 1




South Street – Alternative 2



South Street – Alternatives Comparison


Alternative 1:

- Includes widening for 2-foot shoulder
- Granite curb
- 5-foot HMA sidewalk
- Substantial distance to ROW




Alternative 2:

- No widening
- Granite curb
- 8-foot HMA sidewalk
- Substantial distance to ROW




Similar slope limits and no anticipated ROW impacts

Alternative 1:


Includes widening for 2-foot shoulder

Grass buffer

Abuts ROW and may require short permanent easements (PEs) and wetland impacts



Alternative 2:


No widening

Granite curb


8-foot HMA sidewalk

Requires relay of gas line and R&R some UPs


Requires installation of short wall segments to minimize PEs





Either alternative could grade towards trees or install short wall segments to minimize tree and ROW impacts.






8-foot sidewalk continues north of Parallel

Crosswalks through intersections; sidewalk through driveways








Lot curb proposed at back of sidewalk to adjust for existing steep grade











Proposed retaining wall will save several trees and avoid impacts to wetlands










Sidewalk proposed on east side of Sisson increases connections to Town amenities








Proposed sidewalk reconstruction connects to existing network south of School House Drive

Right of Way (ROW) impacts – based on 25% Design

- Impacts to private property include temporary easements and a few permanent easements
- No alterations to the Town layout are anticipated
- Easements are needed for the construction staging and limits of regrading.

Environmental Permitting

- A retaining wall is proposed to avoid wetland impacts on the south side of Main Street
- MEPA review anticipated
 - Will provide additional opportunity for public involvement
- No Historic and Cultural impacts anticipated
- Increase in impervious area due primarily to increased facility width



**How will the

affected?**

Traffic Impacts

- Work zones in or directly adjacent to roadway
- Lane shifts to be utilized where possible
- Short-term alternating one-way traffic setups may be needed in more confined areas
- Variable message signs placed two-weeks prior to inform public
- Officers/flaggers on site during construction can provide information
