PROCEEDINGS

2 MR. LAMOTHE: Thank you. Good 3 evening. Good evening. My name is Herrio 4 Lamothe. I am the project manager for the proposed Park and Ride Expansion and 5 6 improvement at Route 132 in Barnstable, which 7 will be presented today. I am in the project 8 management section at the Massachusetts 9 Department of Transportation Highway Division 10 headquarters in Boston. Welcome to our 11 in-person design public hearing. During this 12 presentation, we'll explain the purpose of the 13 hearing, provide an overview of the 14 right-of-way procedures, and explain the 15 design. Finally, we will explain how you can 16 submit your comments and questions about the 17 project, many of which can be included in the 18 official hearing transcript. Let me welcome our panelists from 18 MassDOT who have joined us this evening. As 19 mentioned previously, I am Herrio Lamothe, the 20 MassDOT project manager. We have Rich Bilski. 21 He is a District 5 project development 22 Rich? We have also Lisa Szamreta, engineer. 23 the ROW representative. We have Gareth 24 Saunders, legislative affairs. We have Miranda

1 Briseno, our producer. And from our 2 consultant, BSC group, MassDOT consultant for 3 this project, we have Wayne Keefner, P.E. So, 4 he is a highway engineer. And we have a Cape Cod Commission. 5 6 We have Steve Tupper is the deputy director. 7 Steve? And also we have Colleen Mederos. No, 8 the transportation program manager can't be 9 with us tonight. So -- but we appreciate what 10 they did for us last night. And we are having 11 municipal liaison, Griffin Beaudoin, P.E., the town engineer. And there should be other 12 13 people but -- that may be on his way, but we 14 have received his help last night, too. We 15 have also from the HNTB Patrick Marvin. He's 16 the community and public engagement. So we 17 also have with us for translation, Portuguese 18 Thank you for being here with we have Sara. 19 us. And for Spanish, we have Saul with us. So 20 -- and here tonight to provide the complete 21 verbatim transcript is our stenographers from 22 Advanced Court Reporters, LLC. So we have two 23 with -- present with us. 24 The project How did we get here?

1 started in 2020, with the approval of the 2 project need and initiation forms, and then the 3 approval of the project review committee. Various options are investigated and presented 4 at the 25 percent design stage. The selected 5 6 concept is presented at a design public hearing 7 before proceeding into the final design phase. 8 I would like to invite Steven to provide the 9 overview about the story of this project, 10 Steve, please. Thank you. Thank you, Herrio. So, 11 MR. TUPPER: 12 again, Steven Tupper, deputy director with the 13 Cape Cod Commission. So first, I want to thank 14 MassDOT for inviting us to provide some 15 comments about the context of this project. 16 And I also I want to thank everyone for joining 17 tonight. On the next slide here, I wanted to 18 highlight some data collection activities. 19 Understanding the regional importance of this 20 facility to residents and also a gateway to 21 visitors into our region. We've been 22 collecting data at this facility for 30 years. 23 And that's been over 300 different 24 comps where we've been out there, counting the

1 number of parked vehicles, number of empty 2 spaces, number of illegally parked vehicles 3 primarily. We've also done other data collection activities, for example, looking at 4 the license plate to understand where the 5 6 vehicles are coming from. We certainly saw 7 that this -- this facility draws vehicles from 8 Barnstable all the way out to Provincetown 9 using this facility. Also I want to 10 acknowledge that the town of Barnstable Parking 11 Management Department is out here regularly 12 monitoring it. So they have data as well in terms of the, like, illegally parked vehicles 13 14 in this facility. 15 On the next slide, I'd like to 16 highlight a summary of some of the findings 17 over those 30 years of data collection. So on 18 the slide here from left to right is the 19 average occupancy. That would be the percent 20 full. We've seen the lot in each of the years 21 from 1995 up through today. And then I'll add 22 on top here, the maximum occupancy in each So with another click there, you can see 23 year. 24 this is the most full we saw as a lot each year

1	that we observed it. And then on top of that,
2	I'll add a line at 100 percent. So this shows
3	each time when the lot was full.
4	So in in many instances, they're
5	actually over 100 percent, so illegally parked
6	vehicles as well. Also important to highlight
7	85 percent full when the lot is nearly full.
8	So there's only some spots left in the back of
9	the parking lot. A couple of things to note.
10	On the left-hand side, in the late 90s there
11	are approximately 220 vehicles in the lot. And
12	as you can see, it was regularly overcapacity
13	at 220 vehicles. The park and ride was then
14	expanded to 300 vehicles. And then today, we
15	have 365 spaces in the parking lot.
16	All the way on the right, you can
17	also see a little bit of a dip related to the
18	pandemic. You can see that in the 2021 year.
19	We have been seeing the trend upward since the
20	pandemic starting to go back towards a full
21	parking lot at this facility. On the next

observations. This was the last day that we

1 did it before the pandemic -- pandemic related 2 shutdowns. So across the screen here is the 3 percent full from early morning until later in 4 the day. And as you can see here, the lot is effectively full from 6:00 in the morning -- or 5 6 full, completely full from 6:00 in the morning 7 until 4:00 p.m. that day. It didn't start to empty out until late into the evening. 8 9 Keep going? Sorry, there's a little 10 bit of an echo here. We're trying to fix that. 11 I'll keep going since we're all here. So that was when it was completely full, and then on 12 the next click here, you can see that it was 13 14 effectively full well into the evening. 15 (Technical Interruption.) 16 MR. TUPPER: Okay. The show is 17 really for you anyway, so we'll keep on going 18 So with that, I'll keep going onto the anyway. 19 final slide in terms of data collection. There 20 we qo. Let me just go back one. Wait for the 21 host. There we go, thank you. Okay. So with 22 much ado, here is the final slide on data 23 collection. So I wanted to provide a summary 24 of the data collection in the current

1 configuration before the pandemic. So from 2 2003 to 2020. So over the counts we did in 3 that period of time, we saw an average occupancy, so average percent full, 91 percent 4 full. And the lot was nearly full 90 percent 5 6 of the time that we were doing the 7 observations. And the lot was completely full 8 or over full 10 percent of the time. So one 9 out of the ten times that we went there, there 10 was actually no place to park. So that's what 11 we've been seeing at this lot.

12 And I also want to highlight that the 13 high occupancy that we're seeing here is not 14 tied to seasonality. Unlike much of our 15 transportation system, where we have the 16 biggest issues in the summer, this was seen 17 consistently -- consistently across the entire 18 year in terms of those occupancy numbers. So 19 hopefully that helps with the context. And with that, I'll turn it back -- turn it over to 20 21 Wayne.

22	MR. KEEFNER:	Are these working?
23	MR. TUPPER:	They're good. You can
24	just go up and talk.	

1 MR. KEEFNER: Okay. Can you hear me? 2 MR. TUPPER: Yes. 3 MR. KEEFNER: Okay. If I'm too quiet, let me know. So this is what -- showing 4 some of the current issues. There's not enough 5 6 parking spaces to service the -- those using 7 the various bus services that utilize the lot. 8 There's a lack of separated dedicated drop off 9 The current layout mixes bus and areas. 10 automobile traffic, and there's a lack of ADA 11 connectivity throughout the site. So we --12 what do we want to accomplish? This -- this 13 slide shows a list of project goals. We want 14 to provide additional parking spaces to service those utilizing the lot, provide dedicated 15 16 separated drop off areas, separate bus and 17 automobile traffic to improve safety and 18 functioning of the lot, and improve ADA 19 accommodations throughout the site. 20 So what alternatives were considered? 21 As part of the 2020 Cape Cod park and ride lot 22 study, five concepts were developed for the 23 lot. Option A expanded the south parking area 24 to the west and added 110 spaces. Option B

1 expanded the north parking area to the west and 2 added 101 spaces. Option C expanded the south 3 parking lot to the north and west, and expanded 4 the north parking area to the west and added 5 221 spaces. Option D expanded the south 6 parking lot to the north and west and expanded 7 the north parking area to the west and added 8 300 spaces. In Option E, expanded the south 9 parking lot to the north and west and expanded 10 the north parking area to the west and added 11 365 spaces. 12 This next slide is just a summary 13 table of the various alternatives, comparing 14 the additional parking spaces, total spaces, 15 additional land area needed, environmental impacts, and criteria impact. So what's the 16 17 preferred alternative? Option D is a preferred 18 Option D creates 271 net new alternative. 19 spaces for a total future space count of 639. 20 ADA accommodation is improved throughout the 21 site. New bus shelters with expanded capacity

22 are added. Separate bus and vehicular drop off 23 areas are created, and separate bus and vehicle

24 aisles are also created.

1 How has our design progress since we 2 began? Sidewalks are now located within all 3 islands. There are dedicated separate bus and vehicular drop off and pick up areas. We're 4 relocating the existing EV charging stations 5 6 that are recently installed. There's better 7 signage indicating the on ramp to Route 6 and 8 -- and a new turning area before entering Route 9 6. There's better directional parking and 10 circulation, and we are expanding the lighting. 11 I'll now hand this over to Lisa to go over the 12 right of way. 13 MS. SZAMRETA: Hi, everyone. I'm 14 Lisa Szamreta from the Right-of-Way Bureau, and 15 we're responsible for acquiring all the 16 necessary rights in private and public lands 17 for the design, construction, and 18 implementation of this project. Affected 19 property owners will be contacted by personnel 20 from the Right-of-Way Bureau or consultants 21 representing the Massachusetts Department of 22 Transportation Highway Division. The 23 procedures used must comply with state and 24 federal regulations governing the acquisition

process. Affected property owner's rights are protected under the Massachusetts General Preliminary Chapter 79. If a project is receiving federal funds, the property owner's rights are further defined under Title 3 of the real Property Act of 1970 as amended.

7 The current design plan indicates 8 that fee takings, permanent easements, and 9 temporary construction easements will be 10 acquired. The drawings are located at Town 11 Hall, and if you have any questions later on in 12 the forum, I would be happy to answer them. 13 Thank you.

14 MR. TUPPER: Thank you, Lisa. So 15 what are the environmental, cultural resource, 16 and community impacts? I know what you're 17 talking about. There are no environmental 18 resources near the limits of work. Storm water 19 runoff will be managed on-site, and all 20 applicable storm water standards will be met. 21 What is the construction approach? It's 22 anticipated the construction will be performed 23 in five distinct stages. 24 There's a construction moratorium

1 from Memorial Day to Labor Day. Stage one 2 maintains the existing bus pick up area, drop 3 off area, and parking area in the north lot. Stage two completes the improvements to the 4 Stage three constructs --5 north parking area. 6 constructs the expanded parking areas to the 7 south lot. Stage four improves the north half 8 of the existing south parking area, and stage 9 five completes the improvements to the south 10 parking area. 11 So how will users be affected? 12 Pedestrian circulation throughout the parking 13 area will be improved with dedicated walkways

14 between all aisles. New pedestrian curb ramps 15 and new accessible parking spaces will also be 16 Separating bus and automobile created. 17 circulation increases safety by not mixing 18 traffic types. A new bicycle storage area will 19 also be provided. What are the user impacts? 20 During construction, some of the areas of the site will be fenced off for construction. 21 The 22 dedicated bus drop off pick up area will remain 23 functional throughout construction, and a 24 minimum of 300 parking spaces will be available

at all times. I will now hand this back to
 Herrio.

3 MR. LAMOTHE: The project is expected to be ready for advertisement in the summer of 4 2025. So I will keep you informed. Again, you 5 may access the project website by using mobile 6 7 device camera and focusing on the QR code on 8 the slide. You may also access the project 9 website by using the web address provided. The 10 last sheet of the handout would -- is the mail 11 in sheet. It is also available on MassDOT's 12 website. If you have any questions or comments 13 which you would like to submit in writing, you 14 may use this sheet for that purpose. 12	Good evening, everyone.	I'm Gareth Saunders,

3 MR. SAUNDERS: Sure. And who -- who 4 are you representing tonight? 5 MR. HOLCOMB: Michael Holcomb, 6 district director from Senator Cyr. 7 MR. SAUNDERS: Oh, yes. Michael. 8 I'm sorry. 9 Up to the microphone? MR. HOLCOMB: 10 MR. SAUNDERS: Oh, yeah. Please. 11 And we have Michael Holcomb from Senator Cyr's 12 office. 13 MR. HOLCOMB: And I hope you'll all 14 forgive me from reading from my phone. I had 15 an uncooperative printer at the house. I'm 16 pleased to join you tonight for the public 17 comment on the planned expansion of the Route 18 132 Exit 6 Park and Ride on behalf of Senator 19 Cyr. Senator Cyr is pleased to see the robust 20 community engagement on this planned expansion. 21 As commuters and travelers who use this lot 22 know, there has been a growing gap between 23 demand and availability of park and ride 24 capacity proximate to Route 6. This has made

life for Cape Codders commuting daily or taking
 trips to Boston or Logan Airport unnecessarily
 stressful. I often meet Senator Cyr at this
 park and ride to carpool to Boston, and as an
 anxious traveler like me knows, finding a spot
 can be nerve wracking.

7 Senator Cyr is proud to have secured 8 the 7.5 million for park and ride expansions 9 along Route 6, and is particularly proud of the 10 planned work in Barnstable. The creation of 11 271 additional parking spaces at the Exit 6 12 Park and Ride will expand capacity at the 13 juncture of Route 6, where it is most needed. 14 Paired with increased accessible parking and 15 the EV charging stations, revitalized and 16 improved access to this lot with new pickup and 17 drop off areas, improvements to pedestrian 18 facilities and accessibility, expanded bus 19 passenger shelters, and improved lighting, this 20 lot will be fit for purpose again. The need 21 for expanded park and ride capacity on Route 6 22 has been an issue of concern to Cape Codders, 23 from across the region for years, and Senator 24 Cyr is pleased to have played his part in

1 working towards solutions for this issue.

2 Thank you.

3 MR. SAUNDERS: Thank you, Michael,
4 and Senator Cyr's office. Are there any -5 yes, sir.

6 Hi. Excuse me. Good MR. TAMASH: 7 evening. My name is Craig Tamash. I'm vice 8 president of the Barnstable Town Council, and 9 also here -- this is the rest of the council, I 10 Also here is Gordon Starr and Kris quess. 11 Clark, two -- two other councilors. I use this 12 lot semi-frequently for when we go away. We 13 park there and take the bus to Boston. It's 14 very handy. And I believe you had talked about 15 seasonality. I was just curious as to why you 16 would not be doing construction during the 17 summer, for the simple reason that there's no 18 seasonality. Which -- I'm very familiar with 19 the lot, and there really isn't. I mean, it 20 can be more crowded in February than it is in 21 July. So it -- it seems to me to be a waste of 22 part of the construction season by not doing it 23 during the summer season.

As -- as someone who was involved

24

1 with a lot of traffic control, whatever, it 2 certainly makes sense on some of the larger 3 roads not to be doing construction during the Memorial Day to Labor Day period. 4 But I don't think this will be one of them. So I -- I 5 6 certainly do support this having driven a lot 7 around that lot looking for a space several 8 times, that it's very much needed. And thank 9 you for going forward with it. 10 MR. SAUNDERS: Thank you. 11 MR. BILSKI: Oh, yes. My name is Rich Bilski. I'm the project development 12 13 engineer for District 5. That's something that 14 we could definitely investigate. And 15 typically, MassDOT would not do work on the 16 Cape during the moratorium. However, if the 17 town was in agreement that they would support 18 that and we could get a letter from the town, 19 we would definitely consider that. 20 MR. TAMASH: Okay. If I could, 21 Griffin, do you have any views on that? Not to 22 put you on the spot. 23 MR. BEAUDOIN: That's what I'm here 24 for, Councilor. No, I actually agree with you.

1	The fact that we've seen that it's not a
2	seasonal parking lot, I think it makes a
3	tremendous amount of sense to try to get the
4	project done as quickly as possible. So I
5	would be supportive of that as well. So we can
6	certainly talk.
7	MR. TAMASH: Yeah.
8	MR. SAUNDERS: Thank thank you.
9	Go right ahead.
10	MS. CLARK: Thank you very much.
11	Kris Clark, I'm a councilor from Precinct 11 in
12	West Barnstable, and we will be missing the
13	trees that we have become accustomed to in West
14	Barnstable for those that will be cut down to
15	expand this parking lot. I was wondering, not
16	to be disruptive is has there been a more
17	holistic look at this area? Because not only
18	are there businesses right there with the
19	Burger King, and the gas station, and the YMCA,
20	and the housing units with Kimber Woods, but
21	there's a walking trail in the area and a
22	future bike trail that's proposed in that area.
23	So I was just wondering is has there been a
24	holistic look at how to move people? It's not

1 quite an intersection with the college, but the 2 traffic coming from the college happens at the

3 time when classes come out.

And there's also under-utilized 4 parking at the college. And -- and for those 5 6 that -- I was told that when it comes to public 7 transportation, they have to go around the 8 circle that wraps around the college facility. 9 And that maybe if there was a pull out or a 10 turn out so that somebody could be dropped off 11 without going around the horn for the college, 12 that that might be something worth considering. 13 But anyways, I'm glad that the Town of 14 Barnstable does enforcement over there. T know 15 that there have been times when I've seen cars 16 covered with snow when we hadn't had snow for 17 two or three weeks, and some people park there 18 much longer than they should. And because the 19 place is so overcrowded, oftentimes when 20 they're running late for a bus to go on 21 vacation, it's worth paying the ticket because 22 there's no other option. So thank you very 23 much for letting me speak.

24 MR. SAUNDERS: Thank you. I don't

1 know if anyone from the design team or District 2 5 would like to address the holistic look 3 question.

MR. TUPPER: So thank you, Councilor. 4 5 Certainly, there are bigger issues in terms of 6 transportation connectivity in the area. I'm 7 aware of some of those concepts, looking at 8 connectivity to the -- to Four Cs across the 9 street. And I agree there's potentially a need 10 to look at improvements on 132. My 11 understanding of the scope of this project is 12 it's fairly limited to the park and ride 13 facility itself, but that doesn't mean we can't 14 take a look at the adjacent roadways as well. 15 Commission staff are actually looking at some 16 of the safety issues at the ramps, at all of 17 the ramps on the Cape right now, so we are 18 actually looking at that location. So we'll 19 take that into consideration as well and think 20 about potential future projects where we can 21 make those connections as well. Thank you. 22 MR. LAMOTHE: And also, I am aware of 23 trails going behind. So we are thinking that

1 have the share use park to connect the parking 2 to the trails going. And that will be really 3 helpful and just put your power on that and we 4 would like to have this, okay? 5 MR. SAUNDERS: Yes. Thank you. Are 6 there any -- oh, yes, sir. 7 MR. STARR: My name is Gordon Starr. 8 I'm a town councilor for Barnstable Village and 9 Cummaquid. So my -- my question is -- and I 10 asked Griffin this earlier: Wasn't this project 11 pulled back a couple of months ago? We -- we 12 got messages that it wasn't going to happen for 13 a long time. Do you remember that? Mr. -- Mr. 14 Tupper does? 15 MR. TUPPER: Yeah. 16 MR. STARR: Was -- oh, let's get him 17 on camera. 18 MR. TUPPER: So thank you for the 19 question, Councilmember. So you're indeed 20 correct that the funding related to this 21 project was originally on the transportation 22 improvement program, and it was pulled off. 23 And the MassDOT is currently looking at ways to 24 fund the project. So at the same time, they

1 are advancing the design of the project. So 2 that's what you're seeing tonight, continuing 3 to work forward on the design, but there will be a need to identify the specific funding 4 source to move it forward. So you are correct. 5 6 There's a need for the funding on the project. 7 MR. STARR: So -- so the -- the TIP, 8 the transportation improvement plan is a five 9 year county -- county-wide plan using DOT money 10 Like repaving Route 6 is on the for projects. Is the bike trail on the list? 11 list. 12 MR. TUPPER: There are a number of 13 bike trail projects. 14 MR. STARR: Yes. 15 So specifically, the --MR. TUPPER: 16 the Cape Cod Transportation Improvement Program 17 includes all projects that have federal highway 18 or federal transit funding associated with it. 19 Many of which include matching funds from the 20 State. So that includes a number of bike path 21 projects, Yes, the repaving to Route 6. And 22 potentially this project, although there's currently no funding associated with it. 23 MR. STARR: 24 Okay. But there's enough

1 money to design?

I wish there was 9 room for trees, but we found out last night, 10 there's no room for trees. And the enforcement 11 is a question that has to be looked at. The 12 charging stations. I wish there was a way you 13 could have the level two chargers and have --14 be able to unplug somebody's car and plug in 15 somebody else's car. But probably -- you 16 probably can't legally touch somebody else's 17 Because then you could have instead of car. 18 two spaces, you could have four spaces, and --19 with -- with, you know, two spaces per charger. 20 MR. LAMOTHE: But that you can 21 address. 22 MR. KEEFNER: Okay. So the level 23 twos do have two chargers per --

24 MR. STARR: Right.

1 MR. KEEFNER: -- actual things. And 2 the -- the spaces are set up, staggering it, 3 right? So each car would have its own charger 4 from the single level two. So there's five chargers, but it'll charge ten cars. 5 6 MR. STARR: Yeah. But I'm saying 7 each -- each -- it's too bad that each charger 8 can't charge two cars, you know, that if I get 9 there and the -- the car is already charged 10 that's plugged in, I could unplug it and plug 11 my car in. 12 MR. KEEFNER: Oh, I see what you're 13 saying. Like if they are four cars --14 MR. STARR: Yeah, but -- it's 15 probably not legal to -- for me to touch 16 somebody else's car, you know, and pull it out. 17 But I wish you could do that. Because I don't 18 know what the limits if at level two, they 19 could be parked all day, would make sense. But 20 to be there longer than 12 hours doesn't make 21 any sense. And I'm -- but I'm glad they're 22 So I support the project. Thank you. there. 23 MR. SAUNDERS: Thank you. Any -anyone else, any other elected officials or --24

1 okay. So I'll turn it over to Colleen, yes, or 2

3 MR. LAMOTHE: Before -- before that last night we experienced it as something I 4 didn't do was talk about the -- sorry. Last 5 6 night, at which point I would -- something very 7 important. It's not about the parking. It's 8 about improvement in the bus shelter. So we're 9 going to two, two, four. I don't know if you 10 -- if you want to go deeper on that. So what 11 this project is about, improvement for a buses 12 for the PeterPan or this. Do you want to take 13 about or --

14 MR. KEEFNER: Sure. So I mentioned 15 this earlier, but I can maybe just put some 16 numbers to it to make it a little more clear. 17 So there's -- it's one of the previous slides. 18 I mentioned that we are putting in new bus 19 shelters that are expanding the capacity of the 20 shelters. There's currently two bus shelters. 21 When we're done there will be four. We reached 22 out to all the bus companies that use this lot, 23 and I think PeterPan was the -- was the most 24 forthcoming with information of what -- what

they thought would be the best count for this. And I want to say the number is 75, but don't quote me on that. But that's what I think it is.

So that's the amount of and because 5 6 of that, we need four shelters. And we have 7 space for four. I think we only really three, 8 but we're putting in four, so -- expanding 9 capacity for the bus shelters. They'll all be 10 brand new. They'll all be very clear like they 11 are today, right, safety. But yeah, expanding 12 the bus shelter capacity.

13 MR. LAMOTHE: And also, we have the 14 accessibility. So we have the ADA compliance. 15 And we have also the sidewalk. And that added 16 -- so once you just park your car and you go to 17 the sidewalk and to go to the -- if you to get 18 We have the bus and accessibility. the bus. 19 And for everybody, everyone, so you have the 20 issue, you could park close. There is -- in 21 front where you have the bus shelters, there's 22 some parking really reserved for people with 23 disabilities. You want to ask something more? 24 We can. On that, no? Okay. That was guick.

Okay. So -- and we thank you.

2 We'd like to thank the following 3 organization for the support for this project. First of all, the Town of Barnstable. I was so 4 5 happy to see all of you there for this project. 6 We have the Barnstable Disability Commission. 7 We have Barnstable Council on Aging, and also 8 the Barnstable Veteran's Services. We have a 9 Cape Cod Metropolitan Planning Organization. We have the South Yarmouth RMV Service Center. 10 11 We have the Greater Hyannis Chamber of 12 Commerce. And I think that's all. So I will 13 to -- Miranda to say something so -- before 14 closing the -- we can ask any actual questions. 15 MS. BRISENO: Yep. So we'll move to 16 the question and answers for tonight. A very 17 small room, and I believe we're all adults 18 here. We can, like, raise our hand and get in 19 line. Use the microphone, if there are any 20 other questions or comments? Sure. Yeah. 21 MS. CLARK: If people were -- who

22 have not been able to participate in either 23 last night's or today's event or this present 24 public hearing, will they be able to access

1 this PowerPoint, or how can we -- how can 2 someone -- how can I direct someone to find 3 this information? Thank you. 4 MS. BRISENO: Do you believe we post the PowerPoint online? 5 6 MR. BILSKI: We do. 7 MS. BRISENO: Yes. 8 MR. BILSKI: PowerPoint will be 9 posted and this edited recording will be posted 10 very close to --11 MS. CLARK: On DOT's website? 12 MR. BILSKI: Yes, on the event page. 13 MS. CLARK: Okay. Will it be on the 14 Cape Cod Commission's site or not there? 15 MR. TUPPER: Well, we will provide a 16 link to it as well, yes. 17 MS. CLARK: Thank you. 18 MS. BRISENO: Any other questions or 19 comments? Sure. Okay. 20 MR. WIRTANEN: Mark Wirtanen in West 21 Barnstable. Can I have a paper copy of 22 tonight's presentation, please? I agree with a 23 previous councilor that said that we should 24 have construction during the summer because as

1 a local, we know we have to share some of that 2 construction hell with the tourists that are 3 here during the summer. Because in the summer we have traffic tourist hell. And in the 4 5 off-season, we have construction traffic hell. 6 So we figured, we'll just share with the -with the tourists for a change. 7 So let's have 8 construction during the summer. The RTA and 9 the B bus, are they going to stop here? So 10 that we can have transportation elsewhere from 11 this location instead of only going to Boston 12 or to Hyannis?

13 There's also a -- an issue with the 14 DOT, the state DOT. If you leave here tonight 15 and you drive west down Route 6A to Route 132, 16 you'll notice the sidewalks. They're 17 completely covered with sand and grass because 18 they haven't been maintained in about 30 years. 19 We've been asking and asking and asking the 20 DOT, which controls them, to do some work on 21 them, but they don't. They do major 22 construction projects, and they're supposedly 23 going to be coming in and -- and redoing the whole sidewalk, making it ADA compliant. 24 But

we've been begging for 30 years, and -- the -the -- so the -- the concern is that once they
build something, they don't maintain it. So
those are my comments. Thank you.

5 MR. BILSKI: Yeah, as far as the other bus carriers, that's why we're doing the 6 7 additional bus shelters. So specifically, so 8 RTA can have their own stop two and the B bus, 9 and we coordinated with all -- I think there's 10 four different carriers. And the main concern 11 was, too, that, you know, somebody who is going 12 to -- let's say you're going to bicycle to your 13 local RTA stop. You could put a bicycle on the 14 You could take an RTA bus to -- to the rack. 15 park and ride. There's going to be -- bicycle 16 racks there, so you could store your bike. And 17 then you could take the bus out to Boston if 18 you wanted to, or New York City, or wherever, 19 any point you wanted to, and just provide that 20 connectivity between the whole system.

Also, as part of adding the additional shelters, we're increasing the whole length of the island to encourage more carpooling drop offs. So if people are going

1 on trips it makes it more convenient because right now, it's -- if you've been there, it's 2 very congested. It's hard when people are 3 picking up or dropping off people. So we would 4 encourage that activity also. And then also my 5 6 understanding it is RTA also runs at certain 7 times, certain medical buses that go up to some 8 of the hospital facilities. So that's why 9 we're increasing also the number of handicapped 10 spots over there, too, to address that.

11 As far as 6A, I know we're looking at 12 various projects there. However, 6A has always 13 been very complicated because of the historic 14 nature of it and Old Kings Highway, and 15 necessary to do a lot of projects would 16 potentially impact trees and other situations. 17 So it's always been a very touchy subject. But 18 we have been coordinating with the commission 19 and the town looking at advancing projects.

20 MR. LAMOTHE: Also we'll improve 21 lighting, so -- for security. So at night, 22 even in the far of the parking lot will --23 people have the light. So they were in the 24 dark, for safety. So that will be, you know,

2 MS. BRISENO: Any other comments or 3 questions?

Good evening, everybody. 4 MR. PHALAN: Paul Phalan. I live in Barnstable. And I have 5 to first thank my councilors. I turn my TV on, 6 7 my government channel, and I see there every single night they're out at a meeting. I can't 8 9 thank them enough. And I sit here as the loan 10 dissenter, apparently. And this is a done 11 I'm very sad and upset to hear that. deal. 12 And -- and I can't leave out Senator Cyr. I 13 have tremendous respect for him. I'm sorry to 14 hear that he's -- this money has been 15 appropriated I heard the gentleman state. Some 16 of the money has been appropriated. 17 I -- I live ten minutes from this 18 park and ride, and I went by there at 5:00 19 tonight. I stopped counting at 40 empty 20 spaces. You can -- I think the state needs to 21 do a better study. With all due respect to the 22 Cape Cod Commission, I think their study is 23 flawed. We need professional people with 24 degrees to look at this. They could -- they --

1 I think the State should, at least, look at 2 limiting it from 21 days down to 10 days. I 3 don't understand that all -- at all. If that's 4 a state policy, that needs to be looked at. We could save \$10 or \$15 million. I didn't know 5 6 the state was that flush with money. Honest to 7 good.

8 My wife and I do frequently use it. 9 We -- we never have a problem. Sometimes I 10 Uber up there. It's a -- it's a \$5 or \$10 Uber 11 ride, depending on the time of day. I thought 12 we were supposed to encourage people to have 13 less carbon footprint. Now we're increasing 14 this parking lot. Does that make sense? I 15 thought we were trying to get people out of 16 their cars. To Griffin are they -- is the 17 State looking -- is the state observing our 18 brand new storm water management rules, 19 regulations in Barnstable? 20 MR. BEAUDOIN: There we go. They 21 haven't filed an application yet, but they --22 they will need to. 23 MR. PHALAN: Well --24

1 I was hoping that -- that we could 2 use the RTA a lot more as -- in addition to an 3 Uber and a Lyft. It seems like we -- we need a feeder system instead of people driving to this 4 location. People could take the RTA or a Lyft 5 6 and be dropped off. It doesn't make sense to 7 -- at this point to -- to drop this much money 8 on -- on a project like this. And totally 9 separate from this, the Cape Cod Gateway 10 Airport looks to spend \$25 million of federal 11 money to expand their park, their -- their 12 runways, and they don't need to either. 13 It's -- I thought we were -- most 14 towns I've lived in in Massachusetts, am I 15 wrong that we've tried to reduce our --16 impervious pavement? And here we are doubling

17 So I hope that you take into consideration it. 18 looking at reducing the 21 days, having a -- a 19 professional company come in here and -- and 20 take a look at the -- at the actual parking 21 numbers. Thank you all very much. Ι 22 appreciate every -- every single one of you. 23 And I guess I just -- at close, I have nothing 24 but accolades for our rank and file Department

1 of Transportation employees. I see them out 2 there daily. I think they're overworked and 3 just like our parking people, I don't know how. 4 I don't -- I think we -- we don't have the 5 resources to maintain this lot. Thank you.

6 MR. LAMOTHE: So thank you so much. 7 Thank you for your comments. I would like to 8 tell you it's not only providing parking spots. 9 We tried to improve this area. So you know, we 10 have two shelters, bus shelters. Now, we 11 provide four. There are also safety -- safety 12 issue. People trying to get to the buses, and 13 basically there's no way for them to go. If 14 you drop someone to go to the -- to take a --15 to the bus. So there's no way to go and to 16 wait and someone with a accessibility issues, 17 they could not -- there's no way to park and to 18 wait for buses to come.

19 So we're doing a lot of improvement. 20 In my understanding, there's a lot of people 21 around the world coming to Cape Cod, visiting, 22 something like that. By providing this parking 23 lot increase that, that would attract more 24 people visiting. They will get money, more

1 money to the town, to Cape Cod because then 2 there's a place for them to come for their 3 vacation or to do different things. So I think it's the -- which are our best, but for the 4 agreement to issue, just talking about. 5 So 6 there's some regulation with MassDOT. We don't 7 do things like that. At every single phase, 25 8 percent, 75 percent, 100 percent, when they 9 desire, they submit the design.

10 There is a bunch of subject matter 11 expert from the -- from District 5, from the --12 or the 10 Park Plaza. So they even went to --13 they reviewed that. They make comments for 14 trees, they will leave you many trees. They 15 will say, okay, there's some maples, there's a 16 maple regulation. This is why we don't -- we 17 didn't extend the parking lot more because 18 there's regulation. Over on just -- we have a 19 maple tree stored. We could not go over 200. 20 For trees there's a -- also, there's a 21 regulation. So at -- when we're going to a 22 review, the 75 percent we'll take in 23 consideration the environmental issue, and 24 we'll maybe invite the town. We will work

1 together to make sure there's no environmental 2 impact. By the way, all the storm water will 3 be managed on-site. We're not going to go to 4 the general system. It's going to manage on-site. So -- and we'll have to continue 5 6 telling us what to take. We have received your 7 comments, and we to take them in consideration. 8 Thank you so much. 9 MS. BRISENO: Any last questions or 10 We do have the -- I'll put the e comments? 11 mail information up somewhere. But yeah, the 12 Cape Cod Commission and the website will be 13 updated with the slides and recording and other 14 information to submit more comments. I want to 15 thank everyone for their comments. This is the 16 public process. So I appreciate your 17 participation, and thank you for coming 18 tonight. 19 MR. LAMOTHE: Okay. So thank you 20 again.
