<u>Project Description:</u> Topsfield – Bridge Replacement, T-06-13, Perkins Row over Mile <u>Project File No. 612076</u>

A Design Public Hearing will be held to present the design for the proposed project in Topsfield, MA.

WHERE: Public Hall at Town Hall 8 West Commons Street Topsfield, MA 01983

WHEN: Tuesday, March 4, 2025 @ 7 PM

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The proposed project consists of replacing the bridge on Perkins Row. The preliminary design indicates that the overall width of the bridge will remain approximately the same as the existing bridge with similar aesthetics. The project aims to preserve the millstones within the proposed scenic lookouts.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The town is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be presented in the hearing.

WHAT IS A PUBLIC HEARING?

WHY A PUBLIC HEARING?

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

WHY NOT A VOTE ON HIGHWAY PLANS?

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

WHAT DOES A PUBLIC HEARING ACCOMPLISH?

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

RIGHT OF WAY CONCERNS

Your Municipality is responsible for securing the right of way for this project. If your property, or a portion of it, must be acquired by the Municipality for highway purposes in the interest of all people of the Commonwealth, your rights are fully protected under the law. Briefly, here are some of the answers to questions you might ask.

1. REASON FOR PROJECT

The completion of this project will serve local needs. The proposed enhancement will also be in the interest of others in the greater community, and provide for the public good.

2. WHO CONTACTS ME?

Representatives of the municipality have already contacted or will contact you. They will explain the procedures used in acquiring any necessary rights in land.

3. WHAT ABOUT DONATIONS? WHAT IS A RIGHT OF ENTRY?

Town officials will often seek donations, of parcels, where permanent rights are required. This procedure will minimize the acquisition cost for your community.


A Right of Entry is a document that is signed by the owner. It allows the Contractor to perform certain types of work on the owner's land. The work is usually minor in nature and frequently consists of loaming/seeding behind sidewalks, new driveway apron work, grading/sloping, and wetland protection, etc. The rights granted are temporary in nature.

4. WHAT IS A FAIR PRICE FOR THE ACQUIRED PARCELS?

In the event that donations are not considered, or completed, every effort will be made to ensure that an equitable value is awarded. Municipal and/or outside appraisers will complete an appraisal. Consideration is given to the type of rights needed, whether in fee, permanent or temporary easements. The appraisal will be the basis for arriving at a fair price (for damages that result).

5. MUST I ACCEPT THE MUNICIPALITY OFFER?

No, if the owner feels that the offer is not fair the owner may petition the courts. This action does not stop or delay the acquisition. The action must occur within 3 years. The owner(s) may be paid pro tanto (for the time being). The pro tanto payment will not prejudice the court's final decision.



PROJECT DESCRIPTION

The proposed project consists of the replacement of Bridge T-06-013, which carries Perkins Row over Mile Brook in Topsfield. The proposed bridge will carry two 10'-0" wide lanes, one 2'-0" shoulder on either side, and one 5'-6" sidewalk on either side. The total out-to-out width of the proposed superstructure is 39 feet.

The existing bridge was constructed in 1905 and consists of a single-span reinforced concrete arch with a stone aesthetic on both traffic and exterior faces. The deteriorating condition of the bridge necessitated the addition of temporary concrete barriers in 2021 limiting traffic to a single lane. The bridge is currently in serious condition and needs to be replaced.

The proposed bridge will consist of a 26'-9" long single span reinforced concrete arch bridge approximating the shape of the existing arch. The proposed structure will highlight the existing millstones. Fascia stones will be installed on the exterior of the arch and wing wall stems, and both faces of the traffic barrier, to closely match the aesthetics of the existing structure.

There are no existing overhead utilities in the vicinity of the bridge that will impose constraints on construction or need to be relocated. There is an existing underground 12" water line running parallel to the structure on the north side that will likely need to be relocated due to proximity to the proposed structure's foundations.

Perkins Row will be closed over Mill Brook during construction. Local-only access will be maintained on Perkins Row on either side of Mill Brook between Brookside Road and Windsor Lane. A detour will be provided to guide traffic around the bridge to the north on Ipswich Road. Due to the proximity of this project to Stewart Elementary School and student access across Mill Brook, the closure along Perkins Row is proposed to take place within one school summer break period so the bridge will be open to traffic by the start of the following school year. Precast concrete construction is planned to minimize the duration of construction and road closure.
