

The proposed project extends along Route 27 (Main Street) from the easterly limit of the adjacent Kelley's Corner project to the westerly limit of the bridge over Route 2. Additional striping improvements may extend beyond these limits. The proposed design of the intersection consists of a mixed-lane roundabout to improve overall safety and mobility by implementing sidewalks, marked crosswalks, and dedicated bicycle accommodations.



**Operational and Safety Concerns:** 

- I. Crashes
  - Route 2 channelized ramp to Route
    27 SB
    - Yield control is overcapacity
    - Skewed approach angle







## **Existing Issues (cont'd)**

**Operational and Safety Concerns:** 

- I. Crashes
  - Left-turn from Route 2 EB Off-ramp to Route 27 NB
    - Heavy traffic on Route 27
    - Inadequate gaps







## **Existing Issues (cont'd)**

## Safety Concerns:

- I. Crashes
  - Left-turn from Route 27 NB to Route
    2 EB On-ramp
    - No refuge for left-turn vehicles
    - Wide undefined travel lane







## **Existing Issues (cont'd)**

## Safety Concerns:

- I. Crashes
  - 1. Acton Medical Associates Driveway
    - Located opposite to channelized ramp



## How will bicyclists and pedestrians be impacted?

## Pedestrian Improvements

- ADA Pedestrian curb ramps provided throughout the intersection
- Proposed 8'-10' shared-use paths along both sides of the roadway
- Highly visible crosswalks
- Short, two-stage crossings
- Enhanced crossing treatments to be determined

## **Bicyclists at Roundabouts**

No bike lanes on a busy street





Slower vehicle operating speeds make roundabouts safer and more comfortable for bicyclists
