What is happening?

MassDOT is hosting a series of Open Houses across the Commonwealth to provide an update on its Electric Vehicle (EV) Infrastructure Deployment Plan as required by the Bipartisan Infrastructure Law’s National Electric Vehicle Infrastructure (NEVI) Formula Program. At each event, MassDOT will provide information on the status of the Program, electric vehicle charging station site selection, future construction operations, and next steps.

How will this affect you?

MassDOT is constructing electric vehicle charging stations and establishing an interconnected network to facilitate reliability across Massachusetts as required by the Bipartisan Infrastructure Law’s NEVI Formula Program. Public involvement throughout the duration of the Plan’s implementation is essential for understanding community interests, needs, and sentiments.
