# **Total Snapshot Enrollment:**

Total membership decreased by 489 members from December 2019 to January 2020. This translates into a -0.03% decrease in total MassHealth caseload.

Adult enrollment decreased by 9524 members or 0.9% Child enrollment decreased by -9035 members or -1.3%

Total Snapshot Enrollment =	Member count as of the last day of the month; not adjusted for retroactive eligibility.
Total Member Months =	Total number of eligible days divided by the number of days in the month. Updated with latest information available at each publication. This is the most accurate representation of enrollment for budgeting purposes.
