Total membership increased by 13,670 members from March 2023 to April 2023. This translates into a 0.60% change in total MassHealth caseload, excluding temporary coverage.

To account for these changes, MassHealth reports two different measures of enrollment in this document:

<u>Total Snapshot Enrollment =</u> Member count as of the last day of the month; not adjusted for retroactive

eligibility.

Total Member Months =Total number of eligible days divided by the number of days in the month.
