Snapshot Enrollment Overview

Total Snapshot Enrollment:

Total membership decreased by -9,327 members from August 2024 to September 2024. This translates to a -0.50% change in total MassHealth caseload, excluding temporary coverage.

Adult enrollment decreased by -10,895 members or -0.8%
Child enrollment increased by 1,568 members or 0.2%

Family enrollment decreased by -858 members or -0.1%
Disabled enrollment decreased by -432 members or -0.2%
Senior enrollment increased by 3,797 members or 1.6%
CarePlus enrollment decreased by -11,726 members or -3.6%

Enrollment Calculation Methodology

MassHealth enrollment in a given month continues to change after the last day of the month due to members subject to retroactive eligibility changes. This can occur due to retroactive eligibility determination, redetermination processing, application verification, eligibility appeals and changes in member aid categories. To account for these changes, MassHealth reports two different measures of enrollment in this document:

Total Snapshot Enrollment = Member count as of the last day of the month; not adjusted for retroactive eligibility.

Total Member Months = Total number of eligible days divided by the number of days in the month. Updated with latest information available at each publication. This is the most accurate representation of enrollment for budgeting purposes.
