FINAL DECISION

On March 13, 2025, the Massachusetts Port Authority (“Massport”) and the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”), agreed to the Department’s issuance of a permit modification to the Final 2023 Massachusetts Permit to Discharge Pollutants to Surface Waters (“the Permit Modification”). On July 2, 2025 the Department issued the Final 2025 Massachusetts Permit Modification to Massport and co-permittees for Logan International Airport. The period for seeking administrative review of the Permit Modification has passed. As a result of the issuance of the Permit Modification, this appeal is now moot. Accordingly, I hereby dismiss this appeal with prejudice.
