Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:
Pursuant to Section 6 of Chapter 14 of the General Laws ${ }^{1}$, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of May 2019, the eleventh month of fiscal year 2019. The attached table shows May 2019 month-to-date tax revenue collections through May 15, 2019, along with changes from the equivalent period in May 2018.
Revenue collections are uneven and weighted toward month-end, and the brief period covered in the mid-month does not provide sufficient data for comparison to prior years. Therefore, the Department urges that mid-month figures should not be used to assess trends or project future revenues.

## Context for May revenues

Historically, May is a mid-size month for collections, ranking seventh of 12 months in each of the last six years. Estimated payments from individuals or from businesses are not significant in May.

The net figure for revenue collections in May is influenced by the individual tax filing season, which generates both inflows and refund outflows during the month. Individual tax returns continue to be received and processed in May, although in a volume well below the peak levels of March and April.

## Highlights

- Total Tax collections for the month-to-date period were $\$ 934$ million, down $\$ 50$ million or $5.1 \%$ versus the same period in May 2018.
- Income Taxes totaled $\$ 696$ million, down $\$ 41$ million or $5.6 \%$ versus the same period in May 2018.
- Sales \& Use Tax collections were $\$ 112$ million, up $\$ 11$ million or $10.6 \%$ versus the same period in May 2018.
- Corporate \& Business Taxes were $\$ 47$ million, down $\$ 10$ million or $17.8 \%$ versus the same period in May 2018.
- Other Taxes totaled $\$ 80$ million, down $\$ 9$ million or $10.6 \%$ versus the same period in May 2018.


## Detail

Total Income Tax of $\$ 696$ million for mid-month May comprises the following:

- Withholding of \$548 million, up \$40 million from mid-month May 2018.
- Estimated Payments of \$10 million, down \$3 million from mid-month May 2018.
- Returns/Bills of \$171 million, down \$81 million from mid-month May 2018.
- Refunds of $\$ 34$ million, down $\$ 3$ million from mid-month May 2018. Because refunds are an outflow, this represents a positive variance from the prior year.

Sales \& Use Tax collections of $\$ 112$ million for the May month-to-date period are $\$ 11$ million or $10.6 \%$ more than the equivalent period last year. Only a small proportion of expected Regular Sales and Meals tax remittances, subcategories of Sales \& Use Tax, are received by the mid-month date; the bulk of these payments are expected on or after the $20^{\text {th }}$ of the month.

- $\$ 56$ million in Regular Sales Tax collections, up $\$ 16$ million from mid-month May 2018.
- $\$ 15$ million in Meals Tax revenues, up $\$ 2$ million from mid-month May 2018.
- $\$ 41$ million in Motor Vehicle Sales Tax revenues, down $\$ 8$ million from mid-month May 2018.

Corporate \& Business tax revenues were $\$ 47$ million, down $\$ 10$ million from mid-month May 2018.

All Other includes a number of tax categories including motor fuels, cigarettes, estate taxes, and deeds. All other revenues totaled $\$ 80$ million, which is $\$ 9$ million less than the mid-month May 2018 figure.

Because collections are weighted to the end of the month, we do not use the mid-month figures to project full-month revenue. Comparisons to prior-year periods are unreliable because of normal fluctuations and calendar differences in the short 15-day window of incremental data.
