- I. <u>Call to Order Determination of Quorum</u> A quorum of the Board was present. Dr. Herscu, Board Chair, called the meeting to order at 1:00p.m.
- II. <u>Review of the Agenda & Conflict of Interest</u> The Meeting Agenda was reviewed.

<u>DISCUSSION</u>: Dr. Herscu asked the Board members to review the agenda and disclose if there are any conflicts of interest regarding the items on the agenda. Dr. Herscu disclosed a conflict of interest with agenda item IV (c) Continuing

Education CMR 6.00. The recommendation was to move this item last for discussion and allow for recusal.

<u>ACTION</u>: Dr. Hardy made a motion to approve the agenda as amended; Dr. Dossett seconded the motion. The motion passed unanimously.

III. <u>Approval of Minutes:</u>

The March 27, 2018 minutes were deferred for the next Board meeting in June.

<u>DISCUSSION</u>: Dr. Dossett noted that a motion did not take place for agenda item V CMR 6.00. Mr. Leadholm recommended review of the meeting recording for any edits.

ACTION: Deferred to June 26, 2018 meeting.

The April 24, 2018 minutes were reviewed for approval.

<u>DISCUSSION</u>: Dr. Herscu requested a correction to the spelling of his last name on page 2 of 3.

<u>ACTION</u>: Dr. Hardy made a motion to approve the minutes with correction. Ms. Migliore seconded the motion. The motion passed unanimously.

IV. <u>Regulations</u>

A. Scope of Practice CMR 4.00

<u>DISCUSSION</u>: Mr. Leadholm explained the regulatory approval process. The Board suggested the following changes:

- (1) Dr. Herscu suggested rephrasing 4.02 (a) to read "treatment of physical, emotional, and mental human illness";
- (2) Dr. Dosset suggested updating 4.02 (b) by adding the letter "s" to the end of the word "condition";
- (3) Dr. Herscu suggested adding a new definition in between (d) and (e) under 4.02 to read as follow "Non-invasive: as to examinations, means conducting physical and orificial examination of oral, nasal, auricular, ocular, rectal and vaginal cavities. Non-invasive: as to routes of administration means transdermal, subcutaneous, intra muscular, and sublingual."

- (4) Board Counsel to update 4.02 (1) letter (g) to (h) as a result of the new definition being added.
- (5) Dr. Herscu suggested the removal of 4.03 (1) (b). The Board discussed the value of moving to section 4.03 (2) Patient Records. Ms. Berg provided the pros and cons and the Board agreed with the recommendation to remove.

B. Specialty Practice CMR M.00

DISCUSSION: Dr. Herscu explained the regulatory number will be modified upon completion. Dr. Herscu suggested making some changes in M.04 (1) and(2) by adding patient's name, date and section (9) changing the language structure. After many discussions, the Board decided revisiting these items for the next month meeting. Dr. Herscu suggested rephrasing M.07 to read as "A license with a certificate that has expired for four years must have two licenses." Mr. Leadholm inquired about requirement of reporting Adverse Occurrences. Ms. Berg will do more research on whether naturopathy falls into serious adverse drug event reporting. Dr. Herscu suggested removing standards of practice. Dr. Herscu suggested the following changes:

- (1) N.01 should read as followed; "A licensed naturopathic doctor shall obtain by written application a certificate of naturopathic childbirth from the Board prior to attending naturopathic childbirth services."
- (2) Dr. Herscu suggested changing N.02 (3) (b), (c) & (d) into subsection. Dr. Dossett suggested rephrasing (a) to read as "observing naturopathic medical college or hospital; (b) to read as "observing 150 prenatal visits including care for at least 50 women."; (c) to read as "observing or assisting in the intrapartum care and delivery of 50 childbirths in a hospital or alternative birth setting."
- (3) (e) To read as "a labor and delivery supervised by a naturopathic doctor, and includes hospitalization, shall count as a birth." Dr. Dossett inquired whether a naturopathic doctor must have a CPR certificate. Dr. Herscu answered "yes" CPR certificate is required for CEU's.
