DECISION

STILL RIVER LLC D/B/A RIVER ROCK GRILL 163 MAIN ST.

MAYNARD, MA 01754 LICENSE#: 067600007

VIOLATION DATE: 06/01/2016 HEARING DATE: 11/29/2016

Still River LLC d/b/a River Rock Grill (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 29, 2016, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Bailey's Report.

The following documents are in evidence:

- 1. Investigator Bailey's Compliance Check Field Report dated June 1, 2016;
- 2. Licensee's Stipulation of Facts; and
- 3. Receipt from Sale of Alcohol.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Wednesday, June 1, 2016, at approximately 5:30 p.m., Investigators Doyle and Bailey ("Investigators") investigated the business operation of Still River LLC d/b/a River Rock Grill.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Budweiser Light beer, for four dollars and one cent (\$4.01). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
