DECISION

STILL RIVER LLC D/B/A RIVER ROCK GRILL
163 MAIN ST.
MAYNARD, MA 01754
LICENSE#: 067600007

Still River LLC d/b/a River Rock Grill (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 29, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Bailey's Report.

The following documents are in evidence:

1. Investigator Bailey's Compliance Check Field Report dated June 1, 2016;
2. Licensee's Stipulation of Facts; and
3. Receipt from Sale of Alcohol.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

1. On Wednesday, June 1, 2016, at approximately 5:30 p.m., Investigators Doyle and Bailey ("Investigators") investigated the business operation of Still River LLC d/b/a River Rock Grill.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Budweiser Light beer, for four dollars and one cent (\$4.01). The underage operative was not asked for identification.

CONCLUSION


Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission **suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
