





• For All Ages, the mean number of MCI encounters across 23 ESP providers from October through December is 425. The median number of MCI encounters across providers from October through December 2017 is 372.

Three providers (North Essex, South Pioneer Valley, and Metrowest) recorded a number of encounters that are one or more standard deviations above the average.








Indicator 2: Percent of Encounters Occurring in Community (non- ED) Locations by Provider

Some of the ESPs refer to these CBLs as urgent care centers (UCCs).


































