






**Indicator 2: Percent of Encounters Occurring in Community Location by Month**

*Definition: Percent of distinct MCI encounters that occur in a community versus ED location by month, where payers are MassHealth Non-MCE, MassHealth Non-MBHP, Medicare/Medicaid, MassHealth MBHP, OneCare, Careplus, Uninsured, Medicare Only, DMH Only, Health Safety Net, and Commercial with MassHealth TPL. Community locations encompass mobile locations and the Community-Based Locations (CBLs), which are service delivery sites operated by the ESP.*


All Ages

For All Ages, the proportion of MCI encounters occurring in a community location trended upward over the course of three and a half fiscal years with dips during the summer months. The graph illustrates a seasonal pattern, whereby the percent of MCI encounters occurring in the community is highest during months when children and youth are in school.




Age Group 0-14

For Age Group 0-14, the proportion of MCI encounters occurring in a community location trended upward over the course of two fiscal years. The graph illustrates a seasonal pattern, whereby the percent of MCI encounters occurring in a community location is highest during months when children and youth are in school.




Age Group 15-18

For Age Group 15-18, the proportion of MCI encounters occurring in a community location has trended steadily downward over the course of two fiscal years.





Age Group 19-20



For Age Group 19-20, the proportion of MCI encounters occurring in a community location has trended downward over the course of two fiscal years. There is a steep decrease of MCI Encounters between March and April 2017 from 32% to 22%.



**Indicators 3-5: Number of Distinct MCI Encounters Occurring in Mobile Location, ESP/CB/UCC Location, and ED Location by Month**

Definition: Number of distinct MCI encounters that occur in Mobile, ESP/CB/UCC and ED Location by month, where payers are MassHealth Non-MCE, MassHealth Non-MBHP, Medicare/Medicaid, MassHealth MBHP, OneCare, Careplus, Uninsured, Medicare Only, DMH Only, Health Safety Net, and Commercial with MassHealth TPL.





All Ages

· For all ages the percentage of MCI encounters occurring in an ED location is 48% (1,097/2,273) and the percentage of MCI encounters occurring in a community location is 52% (1,176/2,273) in September 2017 FY 2017.

Age Group 0-14

· For Age Group 0-14, the percentage of MCI encounters occurring in an ED location is 38% (445/1,176) and the percentage of MCI encounters occurring in a community location is 62% (731/1,176) in September 2017 FY 2017.

Age Group 15-18

· For Age Group 15-18, the percentage of MCI encounters occurring in an ED location is about 55% (443/810), and the percentage of MCI encounters occurring in a community location is 45.0% (367/810) in September 2017 FY 2017.

Age Group 19-20

· For Age Group 19-20, the percentage of MCI encounters occurring in an ED location is 73% (209/287), and the percentage of MCI encounters occurring in a community location is 27% (78/287) in September 2017 FY 2017.

All Ages

For All Ages, of those MCI encounters that occurs in a community location in September 2017 is about 67% (772/2,223) occurs in a mobile location and about 33% (377/1,149) occurs in an ESP/CB/UCC location.

Age Group 0-14

For Age Group 0-14, of those MCI encounters that occurs in a community location in September 2017 is about 70% occurs in a mobile location and 30% occurs in an ESP/CB/UCC location.

Age Group 15-18


For Age Group 15-18, of those MCI encounters that occurs in a community location in September 2017, 65% occurs in a mobile location and 35% occurs in an ESP/CB/UCC location.

Age Group 19-20

For Age Group 19-20, of those MCI encounters that occurs in a community location in September 2017, 47% occurs in a mobile location and 53% occurs in an ESP/CB/UCC location.


**Indicator 6: Percent of MCI Encounters Resulting in Inpatient Admission by Month**

*Definition: Percent of distinct MCI encounters with a primary disposition of inpatient psychiatric private, inpatient psychiatric general, observation bed (up to 23 hours) or intensive observation bed (up to 72 hours), where payers are MassHealth Non-MCE, MassHealth Non-MBHP, Medicare/Medicaid, MassHealth MBHP, OneCare, Careplus, Uninsured, Medicare Only, DMH Only, Health Safety Net, and Commercial with MassHealth TPL.*




All Ages

For All Ages, the percentage of MCI encounters resulting in an inpatient admission (inpatient psychiatric at a private hospital, inpatient psychiatric at a general/acute care hospital, observation bed or intensive observation bed) steadily increases between March and July 2017 from 17.0% to 20.0% and then drops between July and September 2017 from 20% to 15%.




Age Group 0-14

For Age Group 0-14, the percentage of MCI encounters resulting in an inpatient admission (inpatient psychiatric at a private hospital, inpatient psychiatric at a general/acute care hospital, observation bed or intensive observation bed) consistently occurs from March to May 2017 at 10% and then increases May to Aug 2017 to 13%.



**Age Group 15-18**

For Age Group 15-18, the percentage of MCI encounters resulting in an inpatient admission (inpatient psychiatric at a private hospital, inpatient psychiatric at a general/acute care hospital, observation bed or intensive observation bed), slightly decreases between November 2016 and March 2017 from 24% to 18%.




**Age Group 19-20**

For Age Group 19-20, the percent of MCI encounters resulting in an inpatient admission (inpatient psychiatric at a private hospital, inpatient psychiatric at a general/acute care hospital, observation bed or intensive observation bed) gradually decrease between February and July 2017 from 38% to 31%.


**Indicator 7: Average Response Time by Month**

*Definition: Average amount of time in minutes between the time the youth is ready to begin the intervention to the start time of MCI encounter, where payers are MassHealth Non-MCE, MassHealth Non-MBHP, Medicare/Medicaid, MassHealth MBHP, OneCare, Careplus, Uninsured, Medicare Only, DMH Only, Health Safety Net, and Commercial with MassHealth TPL.*




All Ages

☑ For All Ages, response-time (from the time youth were ready to begin interventions to the time interventions began) averages at 55 minutes between January 2017 and September 2017.




Age Group 0-14

☑ For Age Group 0-14, response-time (from the time youth were ready to begin interventions to the time interventions began) averages at 50 minutes between Jan 2017 to September 2017. The response-time averages gradually declines February 2017 to 42 minutes but increases steadily through September of the period.



Age Group 15-18

For Age Group 15-18, response-time (from the time youth were ready to begin interventions to the time interventions began) averages at 57 minutes between January 2017 and September 2017. A sharp increase of average response-time occurs between April and May 2017 from 54 to 64 minutes.




Age Group 19-20

For Age Group 19-20, response time (from the time youth were ready to begin interventions to the time interventions began) averages at 70 minutes between January 2017 and September 2017.


**Indicator 8: Percent of MCI Encounters with Response Time < 60 Minutes by Month**


All Ages

- For All Ages, 75% of encounters between January and September 2017 have a response-time less than 60 minutes.




Age Group 0-14

- For Age Group 0-14 percentage decreases of response-time with less than 60 minutes from 81% to 75% between January and September 2017 and a sharp decrease occurs between April and May 2017 from 79% to 74%.



Age Group 15-18

For Age Group 15-18, percentage of MCI encounters with a response-time less than 60 minutes averages 76% between January and September 2017.




Age Group 19-20

For Age Group 19-20 there is a decrease of MCI encounters with a response-time less than 60 minutes between January and September 2017 from 73% to 70% and drops steeply between April and May from 71% to 63%.


**Indicator 9: Percent of MCI Encounters Resulting in CBAT Admission by Month**

*Definition: Percent of distinct MCI encounters with a primary disposition of Community-Based Acute Residential Treatment (CBAT), where payers are MassHealth Non-MCE, MassHealth Non-MBHP, Medicare/Medicaid, MassHealth MBHP, OneCare, Careplus, Uninsured, Medicare Only, DMH Only, Health Safety Net, and Commercial with MassHealth TPL.*




All Ages

For All Ages, the average percentage of MCI encounters resulting in a CBAT admission is 10% from January 2017 to September 2017. The graph overall displays consistances in percentage of MCI encounters ranging from 7% to 11%.




Age Group 0-14

For All Ages, the average percentage of MCI encounters resulting in a CBAT admission is 14.0% from January 2017 to September 2017. The graph overall displays consistances in percentage of MCI encounters ranging from 12.0% to 18.0%. There is a notable increase of CBAT admissions between September and July 2017 from 12.0% to 16.0%.



Age Group 15-18

For All Ages, the average percentage of MCI encounters resulting in a CBAT admission is 9% from January 2017 to September 2017. The graph overall displays consistencies in percentage of MCI encounters ranging from 7% to 12%.



Age Group 19-20

For All Ages, the average percentage of MCI encounters resulting in a CBAT admission is 0% from January 2017 to September 2017. The graph overall displays consistencies in percentage of MCI encounters ranging from 0% to 1%.

**NOTE:** The majority of CBAT providers expect MBHP members to max out at age 18. Individuals within the 19-20 age category could appear within the figures if they were 18 at the time of the initial encounter then turned 19 during their CBAT service.
