Dear Superintendent Ryan:

In accordance with M.G.L. c. 111, §§ 5, 20, and 21, as well as Massachusetts Department of Public Health (Department) Regulations 105 CMR 451.000: Minimum Health and Sanitation Standards and Inspection Procedures for Correctional Facilities; 105 CMR 480.000: Storage and Disposal of Infectious or Physically Dangerous Medical or Biological Waste (State Sanitary Code, Chapter VIII); 105 CMR 590.000: Minimum Sanitation Standards for Food Establishments (State Sanitary Code Chapter X); the 1999 Food Code; and 105 CMR 205.000 Minimum Standards Governing Medical Records and the Conduct of Physical Examinations in Correctional Facilities. I conducted an inspection of MCI Shirley on May 12, 13 & 14, 2014 accompanied by Corey Hopkins, Environmental Health and Safety Officer. Observations and Recommendations

1. The inmate population was 1398 at the time of inspection.
2. The Department recommends that all rooms have a number painted on the door frame for location purposes.
3. The Department recommends that the two structures, buildings # 2 & 4 be closed and secured from entry of rodents. Their roofs are collapsing into the structures and as such are a public nuisance to the general public and a harborage for rodents and insects.
4. The Department recommends that the EHSO Officer establish a monthly check of temperatures of the dishwashers in the facilities.
5. The Department recommends that the hot water be restored to Housing B, immediately or the inmates be relocated to an area that provides them hot water.

This facility does not comply with the Department's Regulations cited above. In accordance with 105 CMR 451.404, please submit a plan of correction within 10 working days of receipt of this notice, indicating the specific corrective steps to be taken, a timetable for such steps, and the date by which correction will be achieved. The plan should be signed by the Superintendent or Administrator and submitted to my attention, at the address listed above.
