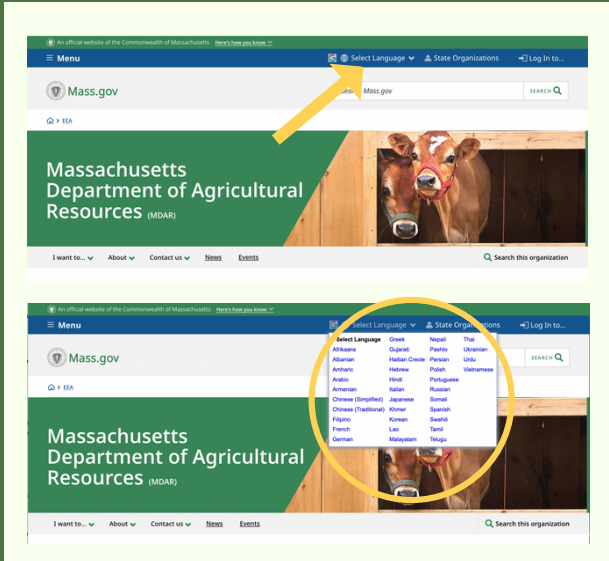

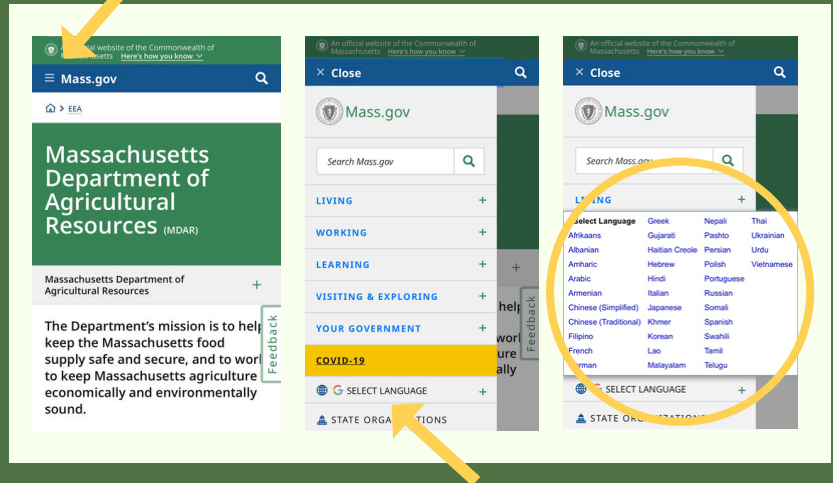

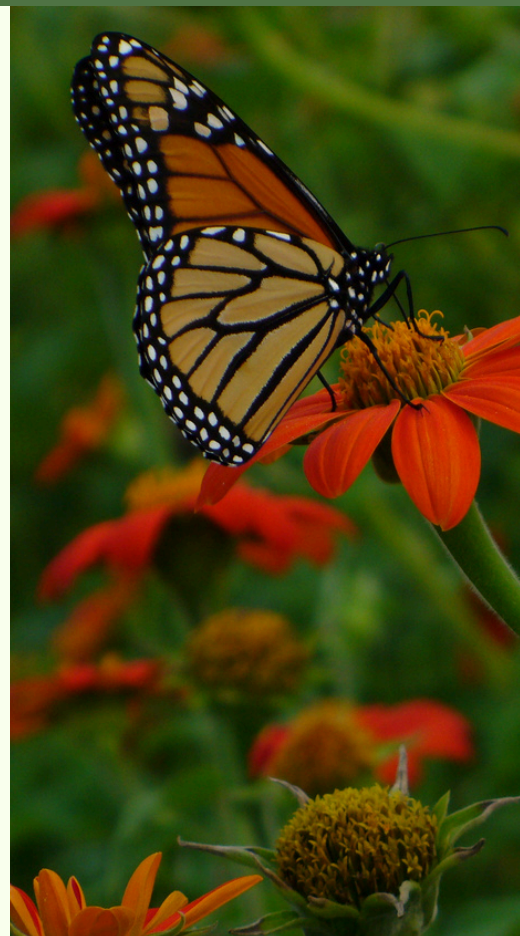


# WELCOME!

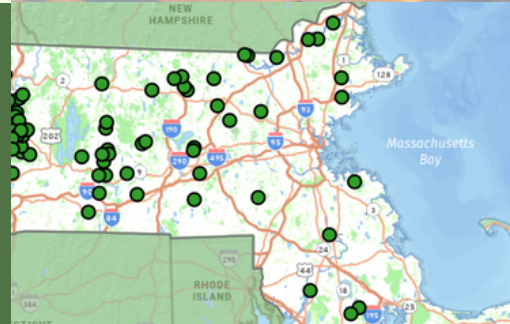

# ARE YOU A FARMER LOOKING FOR LAND ACCESS OR PROTECTION RESOURCES?



## **APR Program:**

Offers a non-development alternative to farmers and other owners of "prime" and "state important" agricultural land who are faced with a decision regarding future use of their farms.

## **Stewardship Assistance and Restoration on APRs:**

Helps resolve stewardship issues caused by a prior owner or natural disaster to restore active commercial farming on land that has already been protected through the APR Program.

# ARE YOU A FARMER LOOKING FOR REBATE PROGRAMS, CREDITS, OR INCENTIVES?

## Organic Cost Share:

Reimburses certified organic farmers and food processors up to 50% (\$500 maximum) of the total certification cost.

## Farm Energy Discount Program:

Provides discounts on electricity and natural gas bills of 10% to eligible entities engaged in production agriculture.

## Dairy Farmer Tax Credit Program:

Intended to offset downturns in milk prices paid to dairy farmers.

## Cranberry Bog Renovation Tax Credit Program:

Provides an offset of 25% of the cost of renovating cranberry bogs in Massachusetts, up to a \$100,000 credit.

## Rollover Protective Structure (ROPS) Retrofit Program:

Rebates 70% of the cost of purchasing and installing the Rollover Protective Structure.

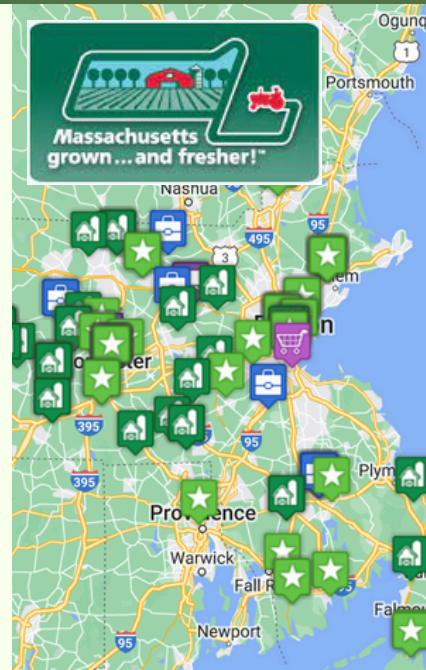
