## **MDOR VPN Setup Procedures**

### Initial Setup:

Install Junos Pulse for windows client on your computer

(Windows Version)



Open Pulse Secure Client Interface and create new connections... File > Connections > Add



Enter a **Name** for the connection: **Vendor IPSEC** (Connection name can be anything you want) Enter a **URL** for the service: **juno.dor.state.ma.us/vendor/ipsec** 

Click the Add button to continue.
