

I. Executive Summary

MED-Project LLC (“MED-Project”) operates a product stewardship program (“Program”) under its Product Stewardship Plan for Opioids and Benzodiazepines from Households (“Plan”) in the Commonwealth of Massachusetts, dated July 16, 2018, approved on November 26, 2018, in compliance with Massachusetts General Law c. 94H, the Drug Stewardship Program. This 2023 Commonwealth of Massachusetts Annual Report (“Report”) describes the activities of MED-Project between January 1, 2023, and December 31, 2023 (the “Reporting Period”). All capitalized terminology not defined in this Report is derived from the Plan.

During the Reporting Period, MED-Project’s Program awarded a total of 171 Funding and Service Grants. MED-Project’s Program provided 120 Funding Grants (one of which was also provided a new Kiosk), and 51 Service Grants (two of which were provided new Kiosks) to Law Enforcement Agencies (“LEAs”) in 2023. During the Reporting Period, Residents received 119 Mail-Back Packages for In-Home Services.

As outlined in the approved Plan, the ultimate goal of the Program is to provide Commonwealth Residents with convenient, safe, and accessible methods to dispose of Covered Drugs.

The Plan identifies Program activities to be described in the annual report, and each section of the Report restates the corresponding Program activity and provides the relevant information.

II. Program Effectiveness

A. Effectiveness Evaluation

The Plan identified eight objectives to help achieve successful Plan implementation. As an indication of the Program effectiveness, all eight objectives were achieved in the Reporting Period by MED-Project as further described in this section.

In addition to implementing the eight Plan objectives, MED-Project implemented a resident survey designed to provide feedback on Program effectiveness. A discussion of the eight objectives and the resident survey is provided below.

1. Plan Objectives

The Plan identified the following eight implementation objectives:

- Provide Residents educational materials on the safe and secure storage of medicine, and on unwanted medicine disposal information through the MED-Project website;
- Provide Residents a convenient single resource for finding disposal options for unwanted medicine in their area through a web-based aggregation tool;
- Enhance MED-Project website awareness in the Commonwealth using search engine optimization;
- Perform outreach to Residents through various media including MED-Project social media postings;
- Provide LEAs information about the Program and how to conveniently apply for a Service or Funding Grant through the MED-Project website;
- Support the collection, transportation and disposal of Unwanted Drugs through the administration of Service or Funding Grants;
- Expand kiosk availability in the Commonwealth through an increase in the number of unwanted medicine collection kiosk sites that meet potential underserved area needs; and
- Provide In-Home Services to Residents including a pre-paid, pre-addressed return Mail-Back Package and/or Disposal Pouches/Kits through the MED-Project website.

OBJECTIVE 1: WEBSITE EDUCATION MATERIALS

During the Reporting Period, MED-Project continued to operate the MED-Project Massachusetts Program website, which among other things provides education materials, including an animated Public Service Announcement video, informational brochures, posters, and frequently asked questions in English and Spanish. The

materials cover the safe and secure storage of medicine as well as information about unwanted medicine disposal.

MED-Project performed an annual update of its website on August 2, 2023, to reflect all known kiosk drop-off locations (both MED-Project and non-MED-Project) throughout the Commonwealth.

OBJECTIVE 2. AGGREGATED SERVICES SEARCH TOOL

During the Reporting Period, MED-Project continued to operate the MED-Project Massachusetts website, which includes a take-back services aggregation tool that allows residents to find take-back resources in the Commonwealth in one place on the web. The MED-Project website experienced over 4,600 page views during the Reporting Period.

OBJECTIVE 3. WEBSITE OPTIMIZATION

MED-Project utilizes search engine optimization tools to ensure that the MED-Project website is prominently displayed in search results related to unwanted medicine, Unwanted Drugs, and their storage or disposal in the Commonwealth. Links to MED-Project's social media accounts are also placed prominently on the MED-Project website.

OBJECTIVE 4. MEDIA CAMPAIGN

During the Reporting Period, MED-Project performed print, digital, and social media campaigns that ran on various platforms. These outreach activities totaled over two million impressions over the two campaigns. MED-Project targeted one of the media campaigns specifically to reach the over age 50 population. For more information on the media campaigns conducted during the Reporting Period, see Appendix A; Media Outreach Summary.

OBJECTIVE 5. LEA GRANT PROGRAM PROMOTION

MED-Project contacted over 450 existing and potential LEA kiosk sites throughout the Commonwealth by:

- Providing Program annual Grant renewal emails or phone calls to participating LEAs to promote annual resubscription in the Grant Program during the Reporting Period.
- Providing an opportunity to participate notification to LEAs that did not participate in the Grant Program in a prior year.
- Providing an opportunity to participate notification to LEAs that had not renewed in the Grant Program at the time of the mailing on March 31, 2023.

OBJECTIVE 6. LEA GRANT PROGRAM IMPLEMENTATION

During the Reporting Period, MED-Project awarded 120 Funding Grants (one of which was also provided a new kiosk) and 51 Service Grants (two of which were also provided new kiosks).

As part of the effort to award Service Grants, MED-Project submitted a request that the Massachusetts Department of Environmental Protection (“DEP”) waive any applicable hazardous waste requirements for LEAs to allow the LEAs to operate unwanted medicine collection kiosks as part of the Program. A DEP waiver has been obtained for all Service Grant sites.

MED-Project notified prior year Grant Program applicants by email to submit a new application for the 2023 Program renewal period. The process for renewing was identical to the application process for a new LEA, taking only a few minutes to complete through the MED-Project website. The fast and simple MED-Project web application process resulted in a rapid renewal rate as well as positive feedback from participating LEAs. 164 LEAs that participated in the Grant Program in a prior year renewed their participation in the Grant Program in 2023.

MED-Project contacted over 450 LEAs during the Reporting Period and recruited seven new LEAs to participate in the Grant Program that had not participated in a prior year, for a total of 171 LEAs participating in the Grant Program during the Reporting Period.

OBJECTIVE 7. INCREASE KIOSK AVAILABILITY

MED-Project approved seven new Grants and installed three new kiosks in 2023.

Of those three kiosks, one was provided through a Funding Grant and two were provided through Service Grants.




Figure 1: Map of Kiosk Drop-Off Sites

Figure 1 is a visualization of statewide kiosk drop-off site locations known to MED-Project, which includes 171 active MED-Project locations and 325 non-MED-Project locations as of December 31, 2023. Figure 1 illustrates the extent of the kiosk availability and convenience across the Commonwealth.

OBJECTIVE 8. PROVIDE IN-HOME SERVICES

During the Reporting Period, MED-Project provided an In-Home Service Program, providing Residents with an additional option for disposing of Covered Drugs from the home. MED-Project previously updated the PSA with a focus on In-Home Service options, which was used in the multi-media campaigns that were conducted in June and November 2023. MED-Project distributed 119 Mail-Back Package orders to Commonwealth Residents during the Reporting Period.

2. Outreach and Awareness Survey

MED-Project conducted a representative annual survey of Residents' awareness of Unwanted Drug issues, including Unwanted Drug disposal options. The survey design

was a random telephone and web survey for Residents. The survey was performed from January 3, 2023, to January 28, 2023, and the results are posted on the MED-Project website.

The survey questions cover topics such as:

- Frequency of Covered Drug use;
- Knowledge of Unwanted Drug safe disposal methods;
- Types of Unwanted Drug disposal methods used by Residents;
- Frequency of Unwanted Drug disposal methods used by Residents;
- How Residents learned of Unwanted Drug disposal options;
- Convenience of provided Unwanted Drug disposal options; and
- Overall perception of Unwanted Drug disposal programs.

Based on the survey results, 58% of Residents are aware of the safe, convenient and free disposal program for expired and/or unwanted medicine in Massachusetts. Additionally, 32% of those surveyed have used drop-off locations, mail-back services, take-back events, or in-home disposal methods to dispose of medicines. Of this group, 62% have used drop-off locations and 54% report they use this method “most” or “all of the time” when disposing of unwanted and/or expired medicines.

As an overall indication of effectiveness and program convenience, the survey reported 84% of Residents who have used drop-box locations believe the program is easy to use, and 84% of the same group of Residents are satisfied with the current medicine disposal program.

MED-Project collected 8,601.0 pounds of unwanted medicine through LEA kiosk sites with a Service Grant during the Reporting Period.

C. In-Home Services

MED-Project provided 119 Mail-Back Packages for In-Home Services during the Reporting Period. There were 47 Mail-Back Packages returned during the reporting

period resulting in the collection of 28.0 pounds of unwanted medicine through Mail-Back Services.

D. Total Weight of Collected Unwanted Medicine

MED-Project collected a total of 8,629.0 pounds of unwanted medicine through all methods during the Reporting Period.

MED-Project conducted the following outreach activities during the Reporting Period: provided print, social, and digital advertisement campaigns; distributed signage and brochures; and maintained the MED-Project website. The website and outreach materials, such as posters and brochures, were available in English and Spanish. Additionally, an animated PSA was available on the MED-Project website. The PSA focuses on providing information about safe storage, usage, and disposal options for Residents.

As part of an initiative to target the over age 50 community, MED-Project conducted a print campaign in the Eldercare Review Magazine on November 16, 2023.

MED-Project also conducted a multi-media campaign targeting the general over age 18 population throughout the Commonwealth. See Appendix A for additional information about the media campaigns. MED-Project website statistics and information are provided in Appendices E and F, respectively. See Appendix G for examples of downloadable brochures and posters.

Social media platforms were utilized as part of the education and outreach program. MED-Project utilized both paid advertising on Facebook and Instagram, as well as organic posts on Facebook and X (formerly known as Twitter) platforms to promote Program information.

MED-Project ran a media campaign to increase Resident awareness of In-Home Service options available in Massachusetts. The PSA was previously updated with a focus on In-Home Service options, which was used in the multi-media campaigns.




Figure 2: MED-Project Website Landing Page




Figure 3: MED-Project Website Medicine Usage Page

Figure 4: MED-Project Website Safe Storage Information Page




Figure 5: MED-Project Website Find A Location Page




Figure 6: MED-Project Website Find A Location Page




Figure 7: MED-Project Website Find A Location Page




Figure 11: MED-Project Website Learn Page




Figure 13: MED-Project Website Video Public Service Announcement Page




Figure 15: MED-Project Website Apply For a Grant Page
