## **DECISION**

PIZZERIA REGINA OF MEDFORD INC. D/B/A PIZZERIA REGINA 44 STATION LANDING MEDFORD, MA 02155 LICENSE#: 068000058

VIOLATION DATE: 04/08/2016 **HEARING DATE: 06/21/2016** 

Pizzeria Regina of Medford Inc. d/b/a Pizzeria Regina (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 21, 2016, regarding an alleged violation of 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 -Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

- 1. Investigator Di Cicco's Compliance Check Field Report dated April 8, 2016; and
- 2. Licensee's Stipulation of Facts.
- A. Photograph of Room on Licensed Premises; and
- B. Employees' Sign-In Sheet for Safe Service Alcohol Training.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

1. On Friday, April 8, 2016, at approximately 5:35 p.m., Investigators Temple and Di Cicco ("Investigators") investigated the business operation of Pizzeria Regina of Medford Inc. d/b/a Pizzeria Regina.

2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, for three dollars and ninety-one cents (\$3.91). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for ten (10) years and has had no previous violations, the Commission issues a WARNING.
