DECISION

PRAGATHARI LLC D/B/A WEST MEDWAY LIQUORS

Pragathari LLC d/b/a West Medway Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, August 12, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Smith and Temple's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Smith and Temple's Minimum Purchase Age Compliance Check Field Report, 5/19/2025;
2. ABCC Form 43, Transfer of License Approval, 8/12/2014;
3. Licensee's Stipulation of Facts.

FINDINGS OF FACT


1. On Monday, May 19, 2025, at approximately 5:57 p.m., Investigators Smith and Temple ("Investigators") conducted a compliance check at Pragathari LLC d/b/a West Medway Liquors.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25-ounce Bud Light beer for three dollars and seventy-five cents (\$3.75). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2014.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.


