2. Establishing the Subcommittee's Focus

- Defining LTSS (Long-Term Services and Supports):
 - LTSS enable individuals with disabilities to live independently in the community rather than in institutional settings. Services include Personal Care Assistants, MassHealth-funded programs, and community-based supports.
 - Budget cuts in House 1 pose significant challenges to these services, particularly affecting individuals with intellectual and developmental disabilities (ID/DD).
- Role of the Subcommittee:
 - Education hub:
 - While the subcommittee cannot endorse specific budgetary measures, it can highlight the real-world impact of these cuts.
 - Identify key resources:
 - Compile a comprehensive list of LTSS programs, including funding sources (state, federal, nonprofit).
 - Engage with MassHealth and other stakeholders:
 - Invite representatives to provide insight into their programs and discuss health equity challenges within the system.
- Key Challenges in Healthcare Equity for People with Disabilities:
 - \circ Medical bias:
 - Many healthcare settings fail to accommodate individuals with disabilities (e.g., inaccessible examination tables).
 - Crisis care disparities:
 - During emergencies (such as COVID-19), medical resources were triaged, often deprioritizing disabled individuals.
 - Dismantling of DEI efforts:
 - Growing opposition to DEI initiatives threatens disability representation in policymaking.
- Building a Unified Voice:
 - Medicaid block grants are under attack, putting critical supports at risk.
 - Coalition-building: Connect with organizations such as the MassHealth Council, Health Care for All, BCBS Foundation, Health Equity Compact, and national disability advocacy groups.
 - Interdisciplinary partnerships: Expand collaboration across healthcare, legal, and disability rights organizations.
- 3. Goal Discussion
 - Develop strong intersectional partnerships that go beyond MassHealth to include broader disability-related services.
 - Expand LTSS access and protections for those receiving services beyond MassHealth.
 - Re-engage with the Health Equity Compact to ensure disability is included in health equity discussions.
 - Support independent living and nursing home choice:
 - Ensure that institutionalization remains a choice, rather than a forced outcome due to service limitations.
 - Improve provider education:
 - Address the lack of training for healthcare providers on disability-related care.

- Identify key stakeholders to broaden outreach efforts, particularly in rural healthcare deserts where access is more limited.
