




Bridge Replacement

- Phase 2 – Intermittent clearing on west side of alignment as needed.












Old Track Removal

- 5,500 feet of used rail removed
- Rail to be recycled
- Footprint will be future home of light rail for Green Line Extension











Right of Way Trash Cleanup

- Focus on west side of alignment where we have access with heavy equipment
- More than 300 tons of trash removed to date
- Supports project Integrated
 Pest Management Program











- Integrated Pest Management
 - Weekly Inspections of baiting stations continue
- Pre-Construction Survey
 - Focus continues on the east side of alignment
 - 147 of 221 property inspections complete in phase I
- Soil Boring
 - Used to determine geological conditions in support design effort
 - Work wrapping up w/ 447 soil core samples pulled













Utility Test Pitting

- Work to confirm utility locations continue in support of design & construction
- 165 of 249 Test Pits (as of June 29)
- Soil Pre-Characterization for Reuse
 - 161 Geoprobes completed
