Combination Improvement Club, Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 3, 2013, regarding an alleged violation of M.G.L. c. 138, §23 – Sale of Alcoholic Beverages other than those purchased from a licensee under §18 or §19 or from a holder of a special license under §22A. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Hooton's Report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts; and
- 2. Investigator Hooton's Investigative Report dated September 6, 2013.

There is one (1) audio recording of this hearing.

FACTS

- 1. On Friday, September 6, 2013, at approximately 12:45 p.m., Investigators Kenny, Wilichoski, and Hooton conducted an investigation of the business operation of Combination Improvement Club, Inc. to determine the manner in which its business was being conducted.
- 2. Investigators conducted an inspection of the bar area and found seven bottles [of alcoholic beverages] that had package store stickers affixed to each bottle. The bottles, I liter each, were:
 - o Bailey's Irish Crème liqueur;
 - Grand Marnier liqueur;
 - o Hennessy cognac;
 - Jack Daniel whiskey;
 - Jameson whiskey;
 - Jose Cuervo tequila;
 - o Sambuca liqueur.

3. Investigators informed the bartender on duty, Bill Legare, of the violation and that a report would be filed with the Chief Investigator for further action.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated M.G.L. c. 138, §23- Sale of Alcoholic Beverages other than those purchased from a licensee under §18 or §19 or from a holder of a special license under §22A. As the licensee has been in business for more than fifty (50) years and has had no previous violations, the Commission issues a **WARNING**.
