Commonwealth of Massachusetts Division of Marine Fisheries 251 Causeway Street, Suite 400 Boston, MA 02114 (617) 626-1520 Fax (617) 626-1509 Email: <u>marine.fish@state.ma.us</u> On April 17, 2012 the Atlantic States Marine Fisheries Commission's (ASMFC) Atlantic Sea Herring Section (consisting of Maine, New Hampshire and Massachusetts Commissioners) approved the following "days out" schedule for the directed commercial Atlantic sea herring fishery in Management Area 1A. Pursuant to 322 CMR 9.05, the Massachusetts Marine Fisheries Advisory Commission (MFAC) will review the 2012 days-out schedule and vote to authorize the Director of the Division of Marine Fisheries to declare days-out specifications for the landing of Atlantic sea herring from Management Area 1A. The MFAC will vote through an electronic poll to be completed by 5:00 PM on Monday, May 14, 2012.

The ASMFC-approved days out schedule is as follows:

• June 1, 2012 - June 30, 2012 During this period, vessels in the directed fishery are authorized Area 1E to land Atlantic sea herring only on Mondays and Tuesdays and will take 5 days out, Wednesdays-Area 3 Sundays. Vessels may only land once Area 2 per day on an authorized landing day and are prohibited from landing in excess of 2,000 pounds of

Atlantic sea herring bycatch on any day out.

- July 1, 2012 July 15, 2012
 During this period, vessels in the directed fishery are authorized to land
 Atlantic sea herring only on Mondays through Thursdays and will take 3 days
 out, Fridays-Sundays. Vessels may only land once per day on an authorized
 landing day and are prohibited from landing in excess of 2,000 pounds of
 Atlantic sea herring bycatch on any day out.
- July 15, 2012 Further Notification
 During this period, vessels in the directed fishery are authorized to land
 Atlantic sea herring seven days per week; there are no days out. Vessels
 may only land once per day on an authorized landing day.

The ASMFC's Atlantic Sea Herring Section will meet on July 2, 2012 and July 25, 2012 to review catch rates and effort in Management Area 1A. Based on their findings, the previously approved days out schedule may be subject to change.
