MA Farmland Action Plan – Drop-In Session for Potential Partners

Notes from online discussion on 6/2/2025

Context

On Monday, June 2, 2025 at 1pm Katharine Otto hosted a drop-in session for potential partners (people who may help with implementation of the plan). The meeting had no presentation – instead the content was guided by questions and comments from attendees. Discussion notes

The following is a brief summary of some of the conversation that occurred in the chat box during the meeting as well as some of the oral comments. It includes links and resources shared with participants.

Community Land Trusts (CLTs)

- How can CLTs fit in with the rest of the partners?
- Acquiring properties and placing them into trust so can then provide farmer access
- History of CLTs being formed out of the civil rights movement so support underserved communities
- How can we incorporate a CLT model into farmland work, including democratically elected board at local level to provide oversight?
- Explore ground lease models
- Is there a central organization for CLTs? The <u>Shumacher Center</u> is working on a guide to CLTs. Some connected to Massachusetts Land Trust Coalition.
- Potential to connect Ag Comms to CLTs
- Potential to connect to Community Development Corporations

Community Preservation Act (CPA) funding

Many are aware of the ability to use <u>CPA</u>, but need more education

No-Net-Loss

- What is meant by this? Freeze or hold on ag land sales? Option for to buy land for the town if the land is being sold for development?
- How could you bring other land into farmland to mitigate?

Matrix tasks

- Tasks often about changing the system how do we shift the needle?
- Importance of "why" not just jump to a solution when looking at tasks. May sometimes need to adjust the task in the matrix to more accurately reflect what can be done to address the issue
