# Massachusetts Fire Training Council Minutes of the June 2, 2021 Meeting

## D. Legislative Update -Counsel Steve Rourke

• There will be a public safety hearing on June 9 and there a number of fire related bills. We'll keep an eye on those bills and report back on any movement.

## E. DFS Update/Academy Activities Report - Deputy Fire Marshal Fournier

- Starting after the next three classes on June 14, the assignment list is 153. Filling July for Springfield; Stow and Bridgewater November class. Remain at 24 in Stow and two classes of 18 will begin in Bridgewater.
- The governor has been made changes and therefore on July 1 we will start open mixed classes of 100% capacity. We looking at a hybrid model for full time employees and will have details next week.
- Interviews for the three candidates for the Director will be next week with myself and the Chairman on the interview team. Maybe we'll have a director by the September meeting.
- The search & rescue prop bids will be out next week and will close the first week in July.
- Relative to the master plan for Bridgewater, we are having planning meetings and working group meetings weekly.
- The CT scan program has nearly 500 approved participants and will end this month. We have re-drafted the new bid for posting. It will also include an advanced blood test.
- Still going through the FY22 budget process.
- Counsel Rourke noted the governor's executive order is repealed effective June 15; back to
  the Open Meeting Law. He filed a bill to extend some of the remote participation. The
  Council will need a physical quorum unless the it votes to have remote participation.
  Chairman noted the Council does not meeting in July & August. In-person meeting will
  take place in September.
