- **Bureau of Forest Fire Control -- Chief Fire Warden David Celino** – we're currently in a drought induced wildfire season. We're still below the 5-year average for acres burned—about 535. We have 1 person out on western mobilization. Monitoring EMAC requests to help if needed. We will begin prescribed burns in southeastern part of the state in October if weather continues to cooperate.

E. Legislative Update – DFS Counsel Glenn Rooney

- Update -- Building code 10th Edition will go into effect on October 11th with a concurrency period with the 9th edition.
- **DFS Update – Marshal Jon Davine**
- Beginning stages of looking into Community Risk Reduction software to provide communities with CRR software.
- The new ISU trailer had successful first deployment to the Big E and received good feedback. It is up and operational if any Chiefs' Associations are interested in a demonstration or if it is needed it for an event—contact DFS.
- FY26 budgets have been submitted and are being reviewed.

- Fire equipment grant paperwork has been sent out.
- SAFE grant should be available by 10/15.
- Dave Clemons busy with the preparations for the 250th anniversary of the battles of Concord and Lexington taking place on Saturday and Sunday, April 17 and 18, 2025. And Monday is the Boston Marathon.
- EMAC requests over weekend from North Carolina after Hurricane Helene for engine company strike force and swift water rescue. Six (6) departments were interested and available for deployment. We submitted package Monday afternoon but were notified Tuesday evening they were no longer needed. Dave Clemons will work with MEMA to possibly offer seminars in how to prepare paperwork for these requests.
- Glenn Rooney and Rachel Perlman have been out presenting supervisory liability in the fire service—they continue to update and revise the presentation with feedback on the information presented. Next virtual delivery has about 200 people registered.
- Dennis Ball Deputy Director Training MFA asked to work with Hayden Duggen to create an Internal CISM group for DFS/MFA for any incidents that could occur similar to what happened with Mass. State Police training academy recently.
- **DFS Update – Deputy Marshal Maribel Fournier**
- Presented MFA Director Job Description for informational purposes; should be posted before the end of October.
- Bridgewater Campus update: Phase 1 infrastructure being done now; footings for Class A burn building have been poured; three 40,000-gal water reclamation tanks are in the ground. Next step is second floor of burn building. Putting out advertisement for Phase 2 for hiring architect to design firehouse and crib.

MFA Update – Acting Director Deputy Marshal Maribel Fournier

- Several Program Coordinator (PC) and Assistant Program Coordinator (AC) positions have been posted and others to be posted: including Flammable Gas, HazMat, Public Safety covering ASHER and Fire Investigator, AC Certification and PC and AC for Call/Volunteer. Some of these positions are in the interviewing process or hiring process or waiting to be posted. Full time PC for Recruit is reviewing applications.
- Recruit classes: we're filling classes: Stow -- December 30 class with 4 openings; Bridgewater -- February class with 21 openings; Springfield filling January class with 24 openings.
- ProBoard accreditation possibly happening in November; waiting for date confirmation.
