## D. Legislative Update - Counsel Steve Rourke

• There has been a flurry of bills filed related to the coronavirus, most are not through the process. Bill by the PFFM to see if 111f benefits could be paid as a result of illness due to the coronavirus.

## E. DFS Update – Fire Marshal Ostroskey

- The agency is nearly 100% remote operation as far as administrative aspects. MFA is operating at a limited capacity at the moment.
- We have a number of things going as a state operation in support of the EOC. Administration support for the bulk of staff to work remotely.
- Continuing to work on open items like the PPE extractor grant initiative; departments are moving forward as well.
- The MPTC will be using the Springfield campus for their recruit academy.
- We had planned to present the overview of the budget and hope to do that at the next meeting.

# F. Academy Activities Report – Director Evans

- We have cancelled, postponed or suspended everything but career recruit training that was ongoing up through April 17. Class 281 and BW01 finished within the last week. Class 282 is ongoing.
- We have invoked temporary protocols at the academy and DFS where we have a new COVID-19 protocol with the help of the executive office, hazmat response and our EMS coordinator. We will be taking the temporal temperatures of all instructors, recruits, and support personnel each day and will send folks home if they have a temp of 100.4. Ask four CDC questions.
- Career Recruit assignments: Stow 171 filling class 286 8-20-20 with 11 seats open Bridgewater – 47 – filling class BW05 9-10-20 with 9 seats open Springfield – 57 – filling class S16 7-9-20 with 10 seats open
- Call/Vol classes 081 and 082 were put on hold for a future date.

- Full-time staff are working remotely except for the Recruit Coordinator. Dennis is here with recruit class and the Deputy Director and I are here alternating days. My coordinator team has been meeting on Zoom on a regular basis.
- We have been tasked by the Marshal to figure out the process for restarting academy classes.
- We are continuing the interview process for the Educational Specialist on the Zoom platform in addition to the RIT Assistant Coordinator.
- Peter Burke has been promoted to Maritime Coordinator and program is on hold.
