

## E. Legislative Update – DFS Counsel Glenn Rooney

## **DFS Update – Marshal Jon Davine**

- We took delivery of our new leak prop that was a capital project, and we just started a new hazmat tech class on Monday.
- We are expecting our new ladder truck hopefully late April, early May.
- We have a couple of Senior Fire Officer forums that are scheduled. Chief Nardelli is doing his presentation on the evacuation of the hospital.
- Our ASHER equipment has finally been delivered, so we will be moving forward with that. We
  have 4 or 5 more sessions scheduled for this fiscal year and then we are in process of scheduling
  the classes for next fiscal year.
- We have graduation in Springfield on Friday and then another one in Bridgewater next Friday.
- We have quite a few vocational schools that have reached out and want to come do a day at one of the campuses.
- We've got the Boston Marathon coming up, on Monday the 15<sup>th</sup>. We've got quite a significant presence there between Haz Mat, JHIRT and our Special Operations division.

#### MFA Update – Director Eric Littmann

- We have 20 recruits slated to begin in Springfield class S37. We also have 20 recruits in Bridgewater class BW30.
- We have had deliveries of the anti-harassment training throughout all the campuses in accordance with the MFTC policy.

# Policy Presentation/Adoption – Staff Charged with a Felony – General Counsel Glenn Rooney

Back in 1996, the Training Council had a policy that prohibited instructors from working for
the Academy if they were charged with a felony. About three years ago, the contract
language for all the instructors was updated. The current contract language went into effect
in 2021 and it will be in effect until 2026. It mirrors the policy that MFTC received. This
policy update is to align with the current contract language and expands the prohibition
against instructors from working if they're charged with a felony to also include a
misdemeanor and administrative investigation regarding misconduct.
