Massachusetts Fire Training Council Minutes of the June 3, 2020 Meeting

Bureau of Forest Fire Control

• Chief David Celino – forwarded DCR Incident Action Plan and a year-to-date fire occurrence for the month of May. We are up two times from last year. We finally were able to get the 2019 volunteer fire assistance grants released to 36 towns that were successful. The bureau is still running under the incident management team. It's a good example of a NIMS compliant system and I could speak with Director Evans about offering training in the form of a workshop or seminar.

E. DFS Update - Deputy Marshal Fournier

- Working to get Career Recruit up and running and is scheduled to start June 8
- Call center for two testing centers will be closing this Friday at 1:00 pm. The state has so many offerings for testing; we booked over 16,000 appointments.
- We continue to work on restarting certification and licensing exams.
- PFAS continuing to work with the vendor; contaminated soil will be removed soon. We're going to be using Sudbury clean water and changing out.

F. Academy Activities Report - Director Evans

- All three campuses begin Career Recruit classes next Monday, June 8 21 days later starting a new class at each campus. We are holding instructor improvements at all three campuses. The Recruit Coordinator will be testing platform tomorrow with students. Recruit assignment have not changed: 171 Stow, 57 Springfield, 47 Bridgewater. We want to run 12 classes at each campus in FY21 to catch up.
- Call/Vol will begin in Fall River and Stow later this month then Springfield will start in July. We gave recruits in the suspended classes first choice.
- I've been tasked with re-starting certification; we will be sending notifications soon.
- We are following CDC and DPH guidelines and will be screening everyone and we will be at 25% capacity for classroom deliveries.
- Met with the Fire Safety Division to get licensing up and running.

- Notification through LMS for new recruit applications starting June 8 will be sent by the Marshal's office.
- Deputy Marshal reported that it appears that the PAT is up and running.
