Call to Order: The meeting was called to order at 10:05 a.m.

Board Business

- **Public Meeting Minutes of November 20, 2020:** After a brief discussion, a MOTION was made by Ms. Woodbury, seconded by Dr. Williams, to approve the Public Meeting Minutes of November 20, 2020 as drafted. The motion passed unanimously.
- Executive Session Minutes of November 20, 2020: After a brief discussion, a MOTION was made by Ms. Paine, seconded by Ms. Creighton, to approve the Executive Session Minutes of November 20, 2020 as drafted. The motion passed unanimously.
- Ratification of Decisions by Board Staff to Approve Applications: A MOTION was
 made by Dr. Williams, seconded by Ms. Woodbury, to approve the decisions made by
 staff on applications processed since the last Board meeting. The motion passed
 unanimously.

Discussion

- Emergency Policy on Pre-Master's Degree Experience: The Board discussed extending this policy, which permits LMHC and LMFT applicants, because of the state of emergency, to make-up missing pre-master's degree experience hours after graduating if they graduated from March 10, 2020 to August 30, 2020. After a brief discussion, a MOTION was made by Ms. Paine, seconded by Ms. Gagliardi, to extend the policy to those who graduated or will graduate through August 31, 2021. The motion passed unanimously.
- Application Deficiency Rates: Mr. Bialas reported on the rates of incomplete applications for each license type. Specifically, Mr. Bialas noted the high rate of submitted LMHC applications that are incomplete when reviewed by Board staff. To reduce the number of incomplete applications, Mr. Bialas will add a list of common problems to the LMHC Application Guide.

Application Review – Request for Hearing on Denial of Application

• Teresa Arroyave-Lopez: The Board reviewed Ms. Arroyave-Lopez's request for a hearing on the denial of her LMHC application. After a brief discussion, a MOTION was made by Ms. Paine, seconded by Ms. Woodbury, to (1) deny the request for a hearing because Ms. Arroyave-Lopez cannot dispute that her master's degree in Social Work is not a master's degree determined by the Board to be in a Related Field required by 262 CMR 2.04(1), and (2) delegate authority to Ms. Paine to review and approve the denial letter. The motion passed unanimously.

The motion passed unanimously by a roll call vote.
