

**DECISION ADOPTING  
RECOMMENDED REMAND DECISION**

I adopt the Recommended Remand Decision ("RRD") of the Presiding Officer. Accordingly this matter is remanded to the Northeast Regional Office of the Massachusetts Department of Environmental Protection ("MassDEP" or "the Department") for further proceedings consistent with the RRD, including the review and issuance of a decision concerning the Petitioner's (Carrie Fryklund) request for a superseding order of conditions pursuant to the Wetlands Regulations, 310 CMR 10.00, and the Wetlands Protection Act, G.L. c. 131 § 40.

This Decision is not appealable pursuant to G.L. c. 30A. See Town of East Longmeadow v. State Advisory Commission, 17 Mass. App. Ct. 939, 940 (1983); Matter of National Development and NDNE Lower Falls, LLC, Docket No. 2008-073, Recommended Remand Decision (January 26, 2009), Decision Adopting Recommended Remand Decision (January 28, 2009).
