**CONSENT AGREEMENT FOR REPRIMAND**

The Massachusetts Board of Registration in Pharmacy ("Board") and Michael Francis Curry ("Licensee"), a pharmacist licensed by the Board, license number PH17914, do hereby stipulate and agree that the following information shall be entered into and become a permanent part of the Licensee's record maintained by the Board:

1. The Licensee acknowledges that the Board opened a Complaint against his Massachusetts pharmacist license related to the conduct set forth in Paragraph 2, identified as Docket Number PHA-2014-0028 ("Complaint").
2. The Board and the Licensee acknowledge and agree that on or about December 9, 2011 Licensee failed to properly verify a prescription, resulting in a Quality Related Event in which the incorrect drug was dispensed to a patient.
3. The Board acknowledges the receipt of documentation demonstrating the following:
  - a. Licensee successfully completed two (2) contact hours of continuing education in the area of medication error prevention<sup>1</sup>;
  - b. Licensee submitted a Medication Error Report to the Institute for Safe Medication Practices ("ISMP"); and
  - c. Licensee submitted an attestation averring that he read and reviewed 247 CMR.

4. Licensee and the Board acknowledge that the Board's receipt of documentation described in Paragraph 3 was a precondition to be met before the Board entered into this Agreement.
5. The Licensee agrees that the Board shall impose a REPRIMAND on his license based on the facts admitted in Paragraph 2, effective as of the date on which the Board signs this Agreement ("Effective Date").
6. The Board agrees that in return for the Licensee's execution and successful compliance with all the requirements of this Agreement, the Board will not prosecute the Complaint.
7. The Licensee understands that he has a right to formal adjudicatory hearing concerning the Complaint and that during said adjudication he would possess the right to confront and cross-examine witnesses, to call witnesses, to present evidence, to testify on his own behalf, to contest the allegations, to present oral argument, to appeal to the courts, and all other rights as set forth in the Massachusetts Administrative Procedures Act, M.G.L. c. 30A, and the Standard Adjudicatory Rules of Practice and Procedure, 801 CMR 1.01 *et seq.* The Licensee further understands that by executing this Agreement he is knowingly and voluntarily waiving his right to a formal adjudication of the Complaint.
8. The Registrant acknowledges that he has been at all times free to seek and use in connection with the Complaint and this Agreement.
9. The Licensee acknowledges that after the Effective Date, the Agreement constitutes a public record of disciplinary action by the Board subject to the Commonwealth of Massachusetts' Public Records Law, M.G.L. c. 4, § 7. The Board may forward a copy of this Agreement to other licensing boards, law enforcement entities, and other individuals or entities as required or permitted by law.
