Puriba Inc. d/b/a Capeway Convenience Store ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 2, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kenny & Terasconi's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Kenny & Terasconi's Minimum Purchase Age Compliance Check Field Report, 5/20/2025;
- 2. ABCC Form 43, Transfer of License Approval, 2/13/2014;
- 3. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Tuesday, May 20, 2025, at approximately 5:05 p.m., Investigators Kenny & Terasconi ("Investigators") conducted a compliance check at Puriba Inc. d/b/a Capeway Convenience Store.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce Truly Hard Seltzer for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2014.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
