Observations and Recommendations

1. The inmate population was 629 at the time of inspection.
2. The kitchen exhaust system was not in compliance with the provisions for inspection, cleaning and labeling required by 527 CMR 1.00, Chapter 50 Commercial Cooking Operations. The CSP was provided documentation stating the hoods are schedule to be cleaned and inspected on September 19, 2022.
3. The Tier Building cell blocks A-L were unoccupied at the time of inspection.
4. During the kitchen inspection the CSP observed expired test strips for the sanitizing solution and recommended obtaining new test strips for the main kitchen and Work Release kitchen.

5. During the inspection of Pod C, it was stated that cell # 2-17 was currently offline and would remain offline until it could be properly cleaned and disinfected.


