# **Observations and Recommendations**

- 1. The inmate population was 677 at the time of inspection.
- 2. During the main kitchen inspection, the warewash machine was not in operation. Kitchen staff stated a service order was already placed to repair the warewash machine and staff had already started utilizing interim measures such as manually sanitizing dishes or using Styrofoam trays until repairs could be made. By the completion of the inspection, the warewash machine was repaired and working in accordance with the manufacturer's instructions.
- 3. The CSP recommends:
  - a. Installing a shower curtain at the toilet stall in the 2<sup>nd</sup> floor bathroom of Work Release House # 1; and
  - b. Utilizing a dehumidifier in the basement of Work Release House # 1 and 2.

This facility does not comply with the Department's Regulations cited above. In accordance with 105 CMR 451.404, please submit a plan of correction within 10 working days of receipt of this notice, indicating the specific corrective steps to be taken, a timetable for such steps, and the date by which correction will be achieved. The plan should be signed by the Superintendent or Administrator and submitted to my attention, at the address listed above.
